MEASURE K: RESOLUTION AUTHORIZING A ONE-TIME GRANT OF DISTRICT-DISCRETIONARY MEASURE K FUNDS, NOT TO EXCEED \$100,000, TO CATALINO TAPIA SCHOLARSHIP FOUNDATION, TO SUPPORT AND EXPAND THE SCHOLARSHIP PROGRAM, PROVIDING AN EXCEPTION TO THE CRITERIA FOR DISTRICT-DISCRETIONARY MEASURE K FUNDS TO ALLOW FOR ADVANCE PAYMENT, AND AUTHORIZING THE COUNTY EXECUTIVE, OR DESIGNEE, TO EXECUTE THE GRANT AGREEMENT

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, **Measure K** is the half-cent general sales tax initially approved by San Mateo County voters in November 2012, and extended in November 2016 for a total of thirty years; and

WHEREAS, the Board and County staff have conducted study sessions and community outreach efforts to inform priorities for **Measure K** spending; and

WHEREAS, the Board has held study sessions on **Measure K** expenditures and anticipated revenue for fiscal years (FY) 2023-25, and has approved funds, divided equally among the supervisorial districts, for one-time district-discretionary needs and projects; and

WHEREAS, Supervisorial District 5 has requested a one-time \$100,000 grant to Catalino Tapia Scholarship Foundation (CTSF) to support and expand the

scholarship program to assist economically disadvantaged scholars in San Mateo County; and

WHEREAS, this item is consistent otherwise with the criteria for district-discretionary **Measure K** funds approved by the Board in December 2018, with the following exception: CTSF has requested 50% (\$50,000) of the grant upfront, rather than as a reimbursement payment, with the remaining 50% (\$50,000) being paid on a reimbursement basis; and

WHEREAS, this Board finds that an exception to the criteria is warranted in this instance in order to support the payment of scholarships; and

WHEREAS, there are sufficient **Measure K** funds in the Non-Departmental Services FY 2023-24 Adopted Budget; and

WHEREAS, it is the Board's intent for the County Executive, or designee, to execute an agreement in the amount of \$100,000 to Catalino Tapia Scholarship Foundation and setting forth the terms of the grant in furtherance of the objectives set forth in the Project Summary section in the Board transmittal attached to this resolution; and

WHEREAS, this Board has been presented with a form of the grant agreement and has examined it and approved it as to both form and content and desires to enter into the agreement.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors approves of said grant, and authorizes the County Executive, or designee, to execute said grant agreement.

BE IT FURTHER RESOLVED that the County Executive or designee is authorized to execute amendments to the grant agreement which modify the County's maximum fiscal obligation by no more than ten percent (10%) or \$25,000 (in aggregate), whichever is less, and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
