Schools: I am passionate about education and do believe that increasing support and guaranteeing access to education in our community at all levels, but particularly at the college level can immensely and positively impact

outcomes at the individual and collective level. I held a marketing and communications manager position with Stanford University for six years that exposed me to the possibilities that education and relevant experiences award our youth. I am myself a first generation college student, immigrant, and my background and lived experience is a testament of how access to college-level education can increase an individual's chances at social mobility and increase the potential for the contributions that they can make to their community. If anything, education is one of the things I would most be interested in contributing to.

Underserved communities: Shortly after moving to the U.S. In 2016, I held a marketing and communications manager position with a local nonprofit in San Mateo. This experience, paired with my bilingual and bicultural background, allowed me to be a more effective force in my organization, understanding the community and being able to connect at a deeper level to discuss their needs and how successfully we were addressing them. I am myself coming from an underserved background and understand scarcity and the need to strengthen the social fabric with effective government support.

Other (Arts): I have a Bachelor Degree in Fine Arts and an MBA. My professional background is a rare mix of artistic sensibility and process-oriented acumen. During my time at Stanford I managed marketing and communications for two art museums. I strongly believe I can contribute in an arts-related capacity as well, by providing effective support to community arts organizations. I was selected to be part of a Redwood City arts board but unfortunately due to a family emergency abroad I wasn't able to make the one in-person meeting required, so I had to sadly decline. After my career with Stanford I pivoted to local government and am now in the path to serve our community in that capacity, as a Communications Program Manager as the most senior communications role in my organization. For these reasons I am equipped to also contribute in the area of the arts.

District Representative

For more than twenty years, Burlingame has been home not just my address, but the place where my children grew up, where I stood on the sidelines at school events, and where I’ve listened to neighbors at kitchen tables and community meetings. Living in District 1, I have heard the worries of parents, seniors, small business owners, and new families, and I have seen how every County decision shows up in very real ways on our streets, in our

classrooms, and in our homes.

Through my work on local commissions, city bodies, and countywide advisory groups, I have learned to hold both a close-up view of our neighborhoods and a broader view of the County as a whole. That combination of lived experience and public service gives me a deep, personal understanding of what our communities need and a strong commitment to making sure the Charter truly reflects the priorities and values of the people who live and work here.

Cities

I have extensive experience working with the City of Burlingame, including four years of service on the Planning Commission and close collaboration with city staff, councilmembers, and community stakeholders on planning, equity, and quality-of-life issues. This work has given me practical, hands-on insight into how the County Charter shapes city county relationships in areas like land use, public safety, transportation, and shared services. By working directly with staff, elected officials, and residents, I have learned how the Charter impacts cities on the ground and how to build strong, effective partnerships between city and county government.

Schools

As a parent whose children attended Burlingame public schools, I have spent years deeply involved in our education community, serving on the school site councils at Lincoln Elementary, Burlingame Intermediate School, and Burlingame High School, and partnering with the Burlingame Community for Education to raise vital funds. Through this work, and my broader advocacy for youth and education-focused initiatives, I have seen firsthand how County decisions shape school safety, youth mental health, transportation, and family stability. My experience with youth-serving programs and civic education has given me a clear understanding of the needs of students, parents, and educators and how county governance can either support or stand in the way of their success.

Organized Labor

My primary background is in program management in large, highly regulated organizations in healthcare, biotech, and technology, where I have led cross-functional programs that included both union and non-union employees. Over more than 25 years, this work has given me a deep appreciation for fair processes, safe working conditions, worker protection, and clear accountability in complex institutions.

While I am not a formal labor leader, I have consistently worked alongside diverse teams and seen how organizational policies and structures directly affect workers' rights, compensation, and representation. I would bring that lens to the Committee's work, especially when considering Charter provisions that impact the County workforce and the people who serve our community every day.

Businesses

With more than 25 years of experience in technology, business, and finance including senior program management roles at Genentech, Kaiser, Meta, and Gilead, I understand firsthand how policy, regulation, and government structures shape employers' decisions, innovation, and economic vitality in our region. I have managed large, complex portfolios with significant budgets, contracts, and multi-stakeholder partnerships in highly regulated environments, which require balancing risk, compliance, and long-term value.

This background gives me a clear, practical lens on how County policies affect business operations, workforce development, and the health of our local economy from small businesses to major employers. On the Charter Review Committee, I would use this experience to rigorously evaluate proposed changes for their real-world impact on innovation, job quality, and regional competitiveness, ensuring that our Charter supports a thriving, resilient economy that works for both workers and employers.

Underserved Communities

Much of my community work centers on equity for people who are too often left out of decisions—women, seniors, low-income families, caregivers, and communities of color. As President of the Commission on the Status of Women and a founding board member of Leadership Council San Mateo County, I focus on lifting those voices and making sure policies are shaped with, not just for, underserved communities.

LGBTQI+

I am a committed ally who has consistently worked on to advance inclusion and belonging for LGBTQI+ community members in both corporate and community settings. While I do not hold a formal leadership role in an LGBTQI+ organization, my equity work centers lived experience, combats discrimination, and advocate for County structures that protect civil rights and ensure every resident's dignity is reflected in our governance.

Seniors

I have poured my heart into learning and tackling senior loneliness and social isolation issues, working on creating intergenerational programs that bring older adults and youth together to share stories, learn technology, and build real human connection. These relationships do more than fill time they restore confidence, spark joy, and remind seniors that they are still seen, value, and needed in our community.

Through this work, I continue to learn and gain a clear, human view of the barriers seniors face housing insecurity, health challenges, transportation gaps, and the quiet pain of feeling left out. I am determined to help shape County structures that make it possible for all of us to age with dignity, community, and a true sense of belonging.

Youth

Much of my intergenerational work is designed to put youth in true leadership roles as partners and co-creators, not just program participants. I work closely with young people through intergenerational programs, Girl Scouts, and civic projects in schools and community spaces, helping them find their voice and learn how to shape the places they live in.

By partnering with youth-focused organizations and engaging young people in voter education and civic life, I've seen how County decisions affect their opportunities, mental health, and trust in government. This experience drives my commitment to ensuring the Charter creates real pathways for youth voice, safe and supportive environments, and meaningful participation in our local democracy.

Environmental Groups

In both my community and professional roles, I consistently weave sustainability and climate resilience into the projects, partnerships, and policy conversations I'm part of. I have engaged with local initiatives that focus on environmental health and community well-being, including efforts recognized by Sustainable San Mateo County, and I treat environmental impact as a core, not optional, consideration.

While I am not a board member just a volunteer at an environmental nonprofit, I approach decisions with a systems lens, recognizing how climate resilience, public health, transportation, and land use are tightly connected. I work to balance environmental stewardship with social and economic equity, and I would bring that integrated perspective to any Charter discussions that touch our county's long-term resilience.

Immigrants

As an immigrant, I know firsthand what it means to navigate new systems, cultures, and institutions while trying to find a sense of belonging. I understand the barriers immigrant families face with language access, information, economic opportunity, and trust in government.

My leadership and community work focus on making public processes more welcoming, accessible, and culturally responsive, so residents who feel far from government can see themselves in it. I am committed to helping shape a Charter that reflects all of San Mateo County ensuring immigrant communities are not only protected but fully included in shaping our shared future.

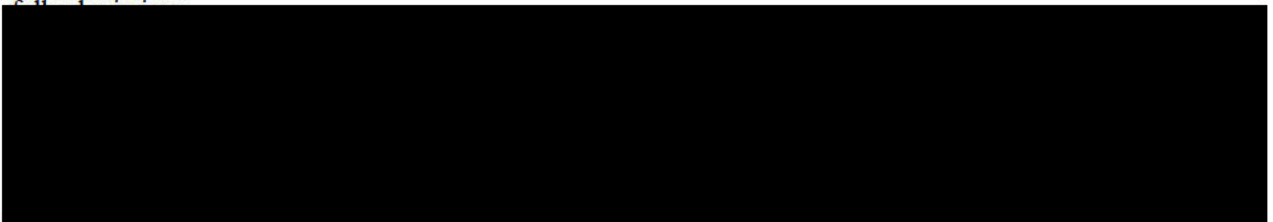

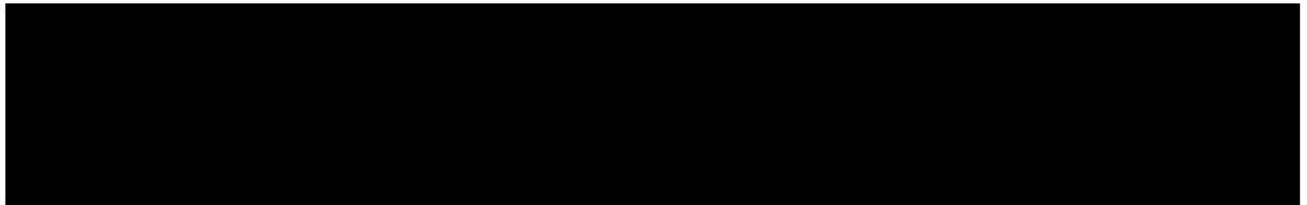

Underserved communities & LGBT Qualifications - My commitment began in my teenage years when I volunteered intermittently at a domestic violence safe house, which was my first exposure to supporting individuals in crisis. In my early 20s, I became deeply involved with LGBTQ+ organizations, volunteering at community centers and Pride events to promote inclusion and visibility. During college, I worked the overnight shift at a domestic violence safe house, providing direct support to survivors. I also assisted sexual assault victims through the court system and delivered public speeches to raise awareness about these issues.

Following that, I joined the Sacramento LGBT Center, where I organized Pride and other community events, fostering safe and affirming spaces for marginalized groups. When I transitioned to Gilead in 2020, I continued this work through the Pride Alliance Employee Resource Group, leading internal and external initiatives that

supported LGBTQ+ communities. Notably, I was the first Pride director in the country to successfully negotiate with Black Lives Matter to participate in our parade and festival, creating unity and avoiding protest through collaboration.

In addition to my advocacy work, I have a personal understanding of health inequities due to living with chronic illnesses. This experience has strengthened my connection to individuals with disabilities and informed my approach to inclusive programming. Currently, my professional role focuses on HIV, a space where intersectionality is critical. I have worked to ensure diversity in clinical trials by influencing protocol development, execution, and advocacy so that underrepresented populations have a voice in research.

Through these experiences, I have demonstrated a lifelong commitment to underserved communities, combining direct service, organizational leadership, and systemic advocacy to create meaningful impact.

Businesses - I bring a strong understanding of business operations from both corporate and entrepreneurial perspectives. For the past eight years, I have worked in a corporate environment, gaining deep insight into how large organizations function, including their structures, compliance requirements, and strategic decision-making processes. Selena is originally from Selma, California, and has lived in the San Francisco Bay Area for the past 18 years. She is a mother, patient advocate, racial equity activist, and social entrepreneur whose leadership is deeply shaped by her lived experience. Selena is the proud daughter of retired Latinx migrant workers, a member of the LGBTQIA+ community, and a carrier of a hereditary cancer condition known as Lynch Syndrome. These intersecting identities inform how she leads, builds relationships, and engages with communities.

Selena co-founded and served as Executive Director of The 559 Mural Project, an organization dedicated to addressing racial injustice and socioeconomic inequity through mural art and community dialogue. Her work centers on amplifying marginalized voices and using creative expression as a tool for healing, education, and

systemic change.

Selena earned a Bachelor of Science in Cellular Biology from the University of California, Davis in 2006 and began her career conducting scientific research at the University of California, San Francisco (UCSF). In 2008, after her family was diagnosed with Lynch Syndrome, Selena became a patient advocate for her family and community. She founded her first nonprofit, Detect The Mutation, to address health inequities in genetic counseling and testing. Through this work, she launched educational initiatives to raise awareness among families, medical providers, and underserved communities of color. Selena has run numerous half-marathons across the United States in honor of family members affected by cancer and has raised funds for organizations including Huntsman Cancer Institute, It Takes Guts, Dana-Farber's Lynch Syndrome Center, and the Cancer Genetics Program at Zuckerberg San Francisco General Hospital.

In addition to writing extensively about her family's story, Selena was a finalist for the inaugural Code Talkers Award sponsored by Invitae and Genome Magazine. She previously worked as a genetic counselor assistant with UCSF's Cancer Genetics & Prevention Program and Cardiovascular Genetics Program, and since 2016 has served on the advisory board for UCSF's Critical Assessment of Genome Interpretation (CAGI) Ethics Forum as a patient advocate advisor. Selena recently became a policy advocate (volunteer) with Facing our Risk of Cancer Empowered (FORCE) and has met with Assemblywoman Diane Papan, to discuss legislation that will strengthen CalGINA 2011.

I am a daughter of immigrants from Hong Kong and the Philippines. I currently serve as a Community Organizer for Policy and Coalitions for Services, Immigrant Rights and Education Network (SIREN), which is an immigrant justice nonprofit that serves our Bay Area counties of San Mateo and Santa Clara as well as our Central Valley counties of Fresno and Madera through community education and organizing, leadership development, legal services, policy advocacy, and civic engagement. I have also served as a former intern for immigration law firms, including Santamaria Law Firm, PC in San Francisco and Ballout Law in San Mateo, in which I have conducted

in-depth research on news reports, country conditions, and health assessments to strengthen attorneys' arguments and assisted with declarations on asylum cases. All these experiences have strengthened my policy, research, advocacy, and communication skills and have shaped my immigrant-rights and community-centered perspective that is crucial to this County Charter Review Committee.

Why are you interested in being appointed to this Charter Review Committee?

I am a lifelong resident of San Mateo County, a Policy and Coalitions Community Organizer with SIREN, and a proud daughter of immigrant parents from Hong Kong and the Philippines.

I have witnessed systemic barriers and racial injustices, fueling my passions for grassroots organizing and policy advocacy. My maternal family's decades-long immigration battle from the Philippines exposed xenophobic policies restricting pathways to citizenship, while my paternal family's journey revealed exploitative work practices against immigrant families. When my loved ones were detained at their green card interview, I experienced the immigration system's frustrating complexities and the trauma of detention facilities tearing my family apart.

I have mobilized communities to create, pass, and implement policy. Through SMCCIR, we collaborated with Supervisor Corzo to strengthen our ordinance, including tracking communications to prohibit cooperation with immigration enforcement. On October 23, when ICE and CBP threatened the Bay, I organized a rally with partners like SMCCIR and SMC AAPI Alliance to proclaim hands off our people. With Santa Clara County coalitions, I helped pass similar policies barring immigration enforcement on our property and banning masked federal agents. With ICE Out of Dublin coalition, I organized public comment toolkits for 30+ Dublin residents and helped unanimously pass our resolution opposing reopening FCI Dublin as an immigration detention facility.

Inspired by my loved ones' stories, I dedicate my life to justice, community, and radical love. I would be honored to contribute my organizing, policy, and advocacy skills to strengthen Charter protections for all in San Mateo County.

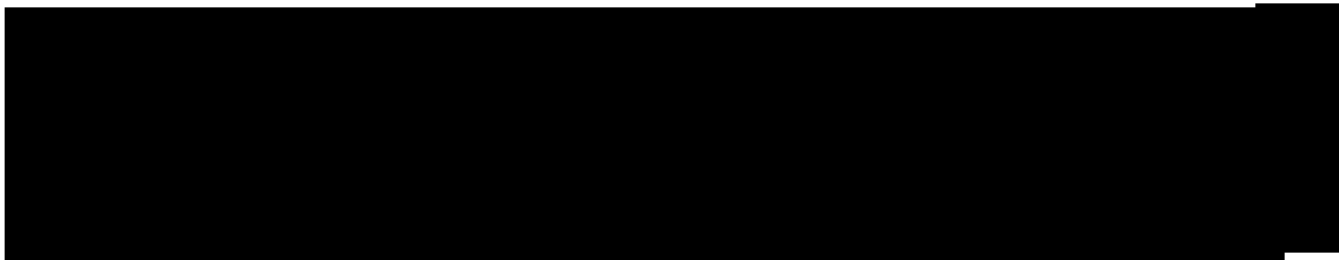
