#### RESOLUTION:

- A) ADOPTING PLANS AND SPECIFICATIONS, INCLUDING CONFORMANCE WITH PREVAILING WAGE SCALE REQUIREMENTS FOR THE RECONSTRUCTION OF EIGHTEENTH AVENUE AND INSTALLATION OF VALLEY GUTTERS ON FAIR OAKS AVENUE IN THE NORTH FAIR OAKS AREA (PROJECT); AND**
- B) AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO CALL FOR SEALED PROPOSALS TO BE RECEIVED BY THURSDAY, FEBRUARY 5, 2026 AT 2:00 P.M. IN THE COUNTY EXECUTIVE OFFICE/CLERK OF THE BOARD OF SUPERVISORS; AND**
- C) AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO EXTEND THE CALL FOR BIDS AND BID OPENING UP TO SIXTY (60) CALENDAR DAYS BEYOND THE TIME AND DATE ORIGINALLY SET FORTH BY THE BOARD OF SUPERVISORS**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, on June 18, 2002 this Board of Supervisors adopted Resolution Nos. 065329 and 065330, which established minimum road standard options and a priority list for road improvements in the North Fair Oaks area, respectively; and

**WHEREAS**, Park Road and Eighteenth Avenue are the next two streets on the North Fair Oaks road priority list for consideration of road improvements; and

**WHEREAS**, property owners on Park Road and Eighteenth Avenue were surveyed to determine if roads improvements were supported; and

**WHEREAS**, the survey results for Park Road from Second Avenue to Seventh Avenue were insufficient to support road improvements, therefore, the Department of Public Works has not proceeded with consideration of road improvements on Park Road; and

**WHEREAS**, the survey results for Eighteenth Avenue, from end to 775 Eighteenth Avenue, received adequate support from property owners for road improvements; and

**WHEREAS**, Eighteenth Avenue will be constructed with two 9-foot wide travel lanes with 2-foot wide valley gutters from the end to Fair Oaks Avenue and 3-foot wide valley gutters from Fair Oaks Avenue to approximately 775 Eighteenth Avenue; and

**WHEREAS**, roadway rehabilitation of the road segment from 775 Eighteenth Avenue to Bay Road has been included in the Project due to the existing conditions without any changes to the roadway configuration; and

**WHEREAS**, Fair Oaks Avenue is on the priority list with valley gutters constructed when adjacent streets on the priority list are reconstructed; and

**WHEREAS**, the public's best interest will be served by including the Fair Oaks Sewer Maintenance District sewer upgrade work along Eighteenth Avenue in this Project; and

**WHEREAS**, plans and specifications dated January 9, 2026 have been prepared and approved by the Director of Public Works for the Reconstruction of Eighteenth Avenue and Installation of Valley Gutters on Fair Oaks Avenue in the North Fair Oaks Area (Project), and said plans and specifications have been filed in the office of the Director of Public Works (the "plans and specifications"); and

**WHEREAS**, the plans and specifications require that the contractors performing the work pay not less than the general prevailing wages, as established by the

Department of Industrial Relations, in the locality in which said work is to be performed for each type of worker needed to execute the contract.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** as follows:

1. The plans and specifications dated January 9, 2026 for the aforesaid Project, which are on file in the office of the Director of Public Works, and to which reference is hereby made for further particulars, are hereby approved and adopted as the plans and specifications to be adhered to in letting and performing the work under a contract for the improvements described therein.
2. Said specifications require that the contractors performing the work pay not less than the general prevailing wages, as established by the Department of Industrial Relations, in the locality in which said work is to be performed for each type of worker needed to execute the contract.
3. The Department of Public Works is authorized and directed to issue a call for sealed bids and to set the bid opening date and time on Thursday, February 5, 2026 at 2:00 p.m. in the office of the County Executive Officer/Clerk of the Board of Supervisors in 500 County Center, Redwood City, California. Said bids will be received by the Clerk of the Board of Supervisors and then transmitted to the County Executive's Office in 500 County Center and be publicly opened and declared.

4. The Director of Public Works is authorized to extend the call for bids and bid opening up to sixty (60) calendar days beyond the time and date originally set forth by the Board of Supervisors.
5. The Department of Public Works is further directed to cause the Notice inviting sealed bids to be published for two (2) times in a weekly local newspaper of general circulation, published in the County, and obtain an affidavit of said publication, a copy of which shall be placed on file with the Department of Public Works.
