BOARD OF SUPERVISORS, COUNTY OF SAN MATEO, STATE OF CALIFORNIA

RESOLUTION AUTHORIZING:

A) AN AGREEMENT WITH ADVANTAGE ASSET TRACKING CORPORATION FOR GLOBAL POSITIONING SYSTEM DEVICES ON COUNTY VEHICLES AND

EQUIPMENT, FOR THE TERM OF JUNE 10, 2025 TO JUNE 9, 2028, IN AN AMOUNT NOT-TO-EXCEED \$540,000; AND

B) AN OPTION TO EXTEND THE AGREEMENT WITH ADVANTAGE ASSET TRACKING CORPORATION FOR UP TO TWO ADDITIONAL ONE-YEAR TERMS, IN AN AMOUNT NOT TO EXCEED AN ADDITIONAL \$180,000 PER YEAR, FOR A TOTAL NOT-TO-EXCEED AMOUNT OF \$900,000, AT THE SOLE DISCRETION OF THE DIRECTOR OF PUBLIC WORKS OR DESIGNEE

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Department of Public Works (Department) is responsible for managing the County's fleet of vehicles and equipment; and

WHEREAS, on November 15, 2011, the Board of Supervisors adopted Resolution No. 071717, which approved funding, in the amount of \$950,000, for the Department's proposal to the SMCSAVES grant program for an online vehicle reservation system to optimize fleet usage and provide data to validate the County's vehicle needs, and installation of Global Positioning System (GPS) devices for all County-owned vehicles; and

WHEREAS, on March 11, 2014 and April 11, 2017, the Board of Supervisors adopted Resolution Nos. 073067 and 075139, respectively, which authorized an agreement with GPS Insight, LLC for the installation of a GPS tracking system on County vehicles for up to a five year term and an amount of \$1,298,755; and

WHEREAS, on April 21, 2020, the Board of Supervisors adopted Resolution No. 077377, which authorized an agreement with GPS Insight, LLC for the continued GPS services for County vehicles for up to a five-year term and an amount of \$921,117; and

WHEREAS, on December 9, 2024, proposals were solicited through the County's e-Procurement system and electronic mail from firms with expertise in GPS and telematics systems for vehicles and equipment; and

WHEREAS, the Department received proposals from 11 firms and an interdepartmental panel reviewed the submittals and Advantage Asset Tracking Corporation was selected as the firm most qualified to provide GPS services for County vehicles and equipment; and

WHEREAS, the Director of Public Works recommends that an agreement be entered into with Advantage Asset Tracking Corporation for GPS devices on County vehicles and equipment for the term of June 10, 2025 to June 9, 2028, in an amount not-to-exceed \$540,000, with options to extend the agreement for two additional one year terms; and

WHEREAS, this Board has considered and concurs with the recommendation of the Director of Public Works; and

WHEREAS, this Board has approved the agreement as to both form and content and desires to enter into this agreement.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board of Supervisors shall be, and is, hereby authorized and directed to execute an agreement on behalf of the County of San Mateo with Advantage Asset Tracking Corporation to provide GPS services for the County's vehicles and equipment for the term of June 10, 2025 through June 9, 2028, in an amount not to exceed \$540,000.

BE IT FURTHER RESOLVED that the President of this Board of Supervisors authorizes an option to extend the agreement with Advantage Asset Tracking Corporation for up to two additional one-year terms, in an amount not to exceed an additional \$180,000 per year, for a total not-to-exceed amount of \$900,000, at the sole discretion of the Director of Public Works or designee.
