FIRST AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND MARINER ADVANCED PHARMACY CORP

THIS AMENDMENT TO THE AGREEMENT, entered into this <u>25</u> day of <u>June</u>.

2024, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Mariner

Advanced Pharmacy Corp, hereinafter called "Contractor";

WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for pharmacy compounding services on April 11, 2024 for the term of April 1, 2024 through July 31, 2024, in an amount not to exceed \$200,000; and

WHEREAS, the parties wish to amend the Agreement to extend the term of the agreement by 32 months through March 31, 2027 and increase the amount of the agreement by \$880,000 to an amount not to exceed \$1,080,000.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3, Payments of the agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall County's total fiscal obligation under this Agreement exceed ONE MILLION EIGHTY THOUSAND DOLLARS (\$1,080,000). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement. All invoices must be approved by the Pharmacy Director or their designee. Invoices must be sent to: SMMC-Accounts-Payable@smcgov.org. Processing time may be delayed if invoices are not submitted electronically.

2. Section 4, Term of the agreement is amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from April 1, 2024, through March 31, 2027.

3. All other terms and conditions of the agreement, between the County and Contractor shall remain in full force and effect.
