I'm Mike Murphy, I've lived in the Lorelei neighborhood, just down Bay Road from Flood Park, for more than twenty years.

I want the Board of Supervisors to seriously consider the request of members of the community to extend Flood Park by using the vacant site of the former Flood School as a soccer field and recreational green space. It would be great to bring soccer to Flood Park, and this would be a way to do it without having to sacrifice the trees of the park's woodland area.

So far, county management has summarily dismissed this idea, but I think you need to look at it, creatively, in the next two weeks, before the Ravenswood School District completes their process of selecting a developer to build out housing on the site.

This idea is gaining momentum in the community. People in the neighborhoods are talking about it, and so is the soccer community. A new petition has gathered more than a hundred signatures in just 3 days online.

Please find a way to work with the School District on this -- it's a way to increase the sports offerings of the park, be good stewards to the trees of the woodland, defuse conflict in the community, and bring this long-vacant lot back to life.

Dear Supervisors,

My name is Finley Mead and I am writing to you on behalf of a group of local students concerned about the current voting system. Plurality voting, where each voter gets one vote, is a deeply flawed practice that inevitably leads to a two-party system forcing citizens to vote strategically instead of for the candidates that best represent their views. This method also leads to candidates that do not represent a majority of their citizens. In the 2020 election, ten out of fifty-seven offices on a county and city level in San Mateo County are not representative of 50% or more of voters, which goes against the foundations of democracy that this nation was founded upon.

To combat this injustice, we propose a ranked choice voting system. In this system, voters may rank candidates on their ballots: first choice, second choice, and so forth. When the votes are tallied, if no candidate has earned the minimum percentage of votes to win the election, the votes for the last-place candidate are transferred to their next choices. This process continues, eliminating last-place candidates and transferring their votes until a winner is declared.

This way, citizens may vote for the candidates they feel best suits them without being concerned about voting strategically or the spoiler effect that makes it impossible for a third party to ever win a plurality election.

We are currently advocating for ranked choice voting on a local scale in the County of San Mateo in order to build momentum and push for change on a greater level. Multiple cities and counties in California have adopted ranked choice voting, and the entire state of Maine uses ranked choice voting for state and national elections. We hope to join the ranks of those already creating a more just and representative democracy for all.

Dear Board of Supervisors,

This is a public comment to the San Mateo County, Board of Supervisor meeting November 9, 2021 regarding the adoption of a new redistricting map. I am a resident of unincorporated greater La Honda and I am urging the Board of Supervisors to consider and adopt the Espinoza Map for the following reasons:

The Espinoza map is the only map that takes into consideration the needs of the unincorporated areas of the county, especially the coastal rural areas, while honoring other communities of interest and minimizing splitting cities. It only splits one city! The unity map would throw us together with the city Pacifica which would introduce a powerful voting block throwing off the balance of power in unincorporated SMC.

The unincorporated coastal areas are a community of interest with very special needs and concerns in that these area share a number of unique issues: extreme wildfire risk, a fragile electric grid with increasingly frequent and unpredictable power outages, a lack of transportation or public services, schools starving of revenue because of shrinking tax base, and most pressing of all, extreme water insecurity due to a fragmented water system of individual wells and tiny aging water districts all competing for the same dwindling supply in our watershed west of skyline. We fear we will not be well represented and will not have a voice if the BOS adopts the Unity map or any other configuration that hands power to cities at the expense of unincorporated areas which have no other form of representation.

I urge the Board to adopt the Espinoza Map.

Dear Supervisors:

The Espinosa Map keeps most communities of interest whole, diversifies districts to meet demographic changes, and splits only ONE city, Burlingame.

Please recognize that the rural (not suburban!) character of the Coastside area makes it absolutely unique in our predominantly urban San Mateo County. Very importantly, the Espinosa Map prevents one incorporated City, Pacifica, from dominating or displacing the interests of the rural Coastside. Pacifica does not share the Coastside interests involving forest wildfires, transportation, water system dis-unity, rural policing, rural highway problems, and lack of access to commercial resources.

Pacifica has proven to be NOT a good political ally with our rural areas, and the small unincorporated communities of the Coastside.

The UNITY MAP suffers from its division of cities. Intuitively, it seems local communities would always have better representation of needs from the cities where they are incorporated, rather than from the County.
