## **DEPARTMENT UPDATE**

San Mateo County Parks Commission April 4, 2024

## **Visitor Experience**

Visitor Data

In Quarter 4 of 2023 (October through December), the San Mateo County parks system served approximately 586,185 visitors. Data indicates that the most visited parks in the system were the Crystal Springs Regional Trail (133,660 visitors), the Coyote Point Recreation Area (122,212 visitors), San Pedro Valley County Park (64,704 visitors), and San Bruno Mountain (49,764 visitors). Raw visitor data is included in this report as Attachment 1.

In total, the San Mateo County parks system served approximately 2,466,027 visitors in 2023. While this figure is lower than in previous years, the Department anticipated a reduction in visitor numbers because of (i) the park closures that occurred in early 2023 due to heavy rain and high wind events and (ii) the number of facilities that were closed for much of the year due to storm damage. Visitor totals are included in this report as Attachment 2.

## Interpretive Events

The Interpretive Division hosted 51 events in the first quarter of 2024, including classroom programs on food webs and animal habitats, a Sam McDonald History Hike, and an Arbor Day event at Huddart Park. The details of each event are included in this report as Attachment 3.

## **Facilities and infrastructure**

Flood Park

At the February 27, 2024 Board of Supervisors meeting, the Board authorized an agreement with Jensen Landscape Contractor, LLC. for the construction of Phase 1 of the Realize Flood Park Project. The agreement is for an amount not to exceed \$8,949,000. Phase 1 of the project includes the small multi-use sports field, tennis/pickleball courts, sand volleyball courts, a full court basketball court, picnic and reservation areas, walking paths, utility infrastructure, and improvements to the northern parking lot. The pump track, which was opened to the public in October 2023, will remain open during construction except for when construction activities occur in immediate proximity to the track. Jensen will mobilize on April 15 to commence demolition and construction; construction is scheduled to conclude in October 2024.

Simultaneously, the Department is conducting the community engagement process for Phase 2 of the Realize Flood Park Project – the playground. The first public design workshop was hosted in Flood Park on March 16 and had approximately 50 people in attendance, most of whom were youth. ## Tunitas Creek Beach

Construction of the Tunitas Creek Beach Improvement Project was suspended in early December 2023 due to heavy rains and ground saturation levels. Project permits require that no grading work occur during rain events or until soils dry to an acceptable level. Given the sporadic rain episodes that have occurred this winter, soils have not dried enough for construction to resume. Rain delays were anticipated and accounted for in the project schedule. At this time, the Department anticipated Tunitas Creek Beach will open to the public in September 2024.

## Coyote Point Recreation Area

Representative Kevin Mullin secured \$1 million in federal funding for the replacement of the aging Magic Mountain playground at Coyote Point. While the funds were included in an appropriation bill that was signed into law by President Biden last month, no details have been provided regarding when the Department can access the funds or when the funds must be committed.

Magic Mountain serves as a regional destination and the Department will conduct an extensive public design process to ensure the new playground provides all the opportunities the public desires in a playground. The Department will keep the Commission apprised as details develop regarding funding obligations and public engagement.

## Pescadero Community Space

In 2022, the County of San Mateo purchased the undeveloped parcel located at the south-west corner of Stage Road and Pescadero Creek Road so it could be developed into a town plaza. Using \$2 million in state funds which were secured by Assemblymember Marc Berman through the 2022 Budget Act, the Department will hire contractors to plan, permit, design, and construct the community space. The Department intends to commence community engagement efforts this spring. No Department funds have been appropriated for this project.

## **Natural Resource Management**

Wildfire Fuel Management

In the first quarter of 2024, the Department partnered with CalFire to reduce approximately 3.5 acres of fire fuels at Pillar Point Bluff. Generally, winter site conditions are not conducive to conducting large-scale fuel reduction projects.

## March 2024 Parks Commission Meeting Summary

The March 2024 Parks Commission meeting included a walking tour of the Coyote Point Recreation Area to discuss the Revitalize Coyote Point effort. The overarching goal for this effort is to provide an elevated experience for all park users by modernizing antiquated facilities and creating new amenities that meet the public's recreational interests and needs. It is essential that this effort enhances Coyote Point's service as both a local and regional destination. During the tour, the Department reviewed the five zones established within Coyote Point: the Beach, the Great Lawn, the Knoll, the Marina, and the Marsh. Attachment 4 shows the boundaries of each zone. While the

Department's contractor, CMG Landscape Architect, has identified ways to improve the flow and function of Coyote Point, themes, amenities, and uses will be determined through a public engagement process.

Unlike the Flood Park project, where a landscape plan was created to serve as a foundation for engineered designs, the Revitalize Coyote Point effort will establish themes for each zone of the park and identify which amenities and uses are most desired by the public. As funding becomes available, the Department will implement individual projects one at a time. This will allow the Department to start the modernization process sooner and in a more efficient manner. No funds have been appropriated for implementation of improvements identified through this effort.

## SAN MATEO COUNTY PARKS COMMISSION FISH & GAME PROPAGATION FUND GRANT GUIDELINES AD HOC SUBCOMMITTEE

Recommendations Summary – For Commission Discussion April 04, 2024

Presented by: Commissioner Meda O. Okelo, Commissioner Irma Rodriguez Mitton

**Purpose**: Review Parks Staff proposed *Guidelines for Funding Recommendations for Fish and Game Propagation Funds (Guidelines*) presented at December 7, 2023 Commission meeting.

- Examination of past Parks Dept budget indicates this fund typically fluctuates between \$2000-4000/year, with annual disbursements of about \$10000. Current fund balance is estimated \$47500.
- 2. Assessment of similar programs in neighboring counties revealed a range of formal guidelines, application requirements, and frequency of fund disbursement. Comparative examples include:
  - Contra Costa good example of a clear process; they specifically encourage projects with a certain theme (enforcement education) and encourage bilingual signage.
  - Solano max grant award \$2500. Good example of short application form and very clear evaluation scoring sheet (Appendix B).

The Ad Hoc Subcommitee's recommendations for consideration are detailed in "Fish and Game Guidelines\_Redline\_040424" (redlined version) of the original Guidelines document. In particular, the subcommittee would like the full commission to discuss the proposed changes to the following areas:

• Item 2: Schedule

• Item 6: Exemptions

• Item 8: Draft Work Product

• Item 12: Educational Program

We propose that after discussion and pursuant to any actions approved by the full commission, that Parks staff move forward with the initial grant cycle, and that the Ad Hoc Subcommitee continue to meet at regular intervals to help staff further refine and adapt the guidelines to best uphold the tenets of the Fish and Game Propagation Funds and serve the people of San Mateo County.

# Guidelines for Funding Recommendations Requests for Funding for from Fish and Game Propagation Funds

The Fish and Game Propagation Fund ("Fund") is a special revenue fund that is maintained by the San Mateo County Parks Department ("Department") and comprised of revenue generated when individuals are fined for violating Sections 12009 and 13003 of the California Fish and Game Code while in San Mateo County. Section 13100 of the California Fish and Game Code states, "[t]he amounts paid to and retained in the county treasury pursuant to Sections 12009 and 13003 shall be deposited in a county fish and wildlife propagation fund and expended for the protection, conservation, propagation, and preservation of fish and wildlife, under the direction of the board of supervisors, pursuant to this chapter."

Pursuant to Section 2.63.020(a) of the San Mateo County Ordinance Code, the County's Parks and Recreation Commission ("Commission") "shall advise the Board of Supervisors regarding fish, game and wildlife policies and programs, and shall make recommendations to the [County's Board of Supervisors] regarding the expenditure of fish and game propagation funds". To fulfill these duties, and with support from the Department, the Commission has adopted the following guidelines which set forth the process by which the Commission: (1) solicits, receives, and evaluate applications from individuals residing in San Mateo County, and/or 501(c)3 organizations, fiscally sponsored community projects, accredited academic institutions, and government agencies, including special districts, seeking fish and game propagation funding; and (2) makes recommendations to the Board regarding the expenditure of fish and game propagation funds.

- 3. Advertising of the Call for Grant Applications: For each grant cycle that occurs, the Department will advertise support the Commission by publicly advertising the Call for Grant Applications, including by posting application materials on the Department's website and, highlighting the Call for Grant Applications process in the Department's monthly newsletter and other communications channels, and receiving application materials on the Commission's behalf.
- 4. Grant Applications Form: To standardize the Call for Grant Applications process, the Department will post a webform application on its website at the opening of each grant cycle. Only complete applications submitted using the approved webform application will be reviewed and considered. The webform application will be similar to the template attached to these guidelines. The Commission will only be presented applications for projects/programs completed within San Mateo County.
  - We propose revising this form to include a clearer statement of eligibility requirements for the applicant and the project, with a clear scoring rubric attached, along with reasonable word limits on narrative responses. This will help ensure all applications provide relevant and complete information of similar length. Please see the attached example from Solano County;
- 5. <u>Compatibility with Fish and Game Code</u>: Submitted applications must clearly identify which section(s) of <u>Fish and Game Code Section 13103 (a)-(m)</u> are applicable to the project/program and explain how the proposed project/program advances the goals of fish and wildlife propagation <u>in San Mateo County</u>.
- 6. <u>Exemptions</u>: In their discretion, the Parks Director, or the Parks Director's Designee, may make exceptions to the aforementioned schedule and present an application from a public land manager (including the Department) or public agency that supports public land managers to the Commission for consideration at any time.
  - For Discussion: Should any exemptions be allowed? If so, we propose this clause explicitly state that any exemptions presented will follow the same application form, eligibility criteria, scoring rubric, and review process (although possibly on an accelerated timeframe) as a proposal considered during the open applicatin period. In addition, the out-of-cycle proposal must include a cover letter detailing the specific need for exemption consideration, such as (but not limited to) an urgent remedy to prevent further habitate or species loss, timely repair or replacement of existing measures, or other justifiable cause.
- 7. <u>Grant Funds Disbursement</u>: Fish and game propagation funds will be expended on a reimbursement basis. Therefore, applicants will need to provide financial statements indicating that they can pay for project/program costs before any grant funds are disbursed.
