DEPARTMENT UPDATE

San Mateo County Parks Commission September 5, 2024

Visitor Experience

Visitor Data

The San Mateo County Parks Department will report visitor data to the Parks Commission on a quarterly basis; however, because visitor data is submitted to the office on the first day of the following month (submitted on October 1 for September) and the Commission meets on the first Thursday of each month, the data will be reported two months after the end of the quarter. For example, Quarter 3 data will be reported in the November Department Report.

Interpretive Events

In Quarter 2 of 2024, the Interpretive Division hosted or participated in 58 events, including classroom programs on wildlife and habitats, a Big Lift event, and Junior Naturalist camps. In total, approximately 2,301 people were served by the division. The details of each event are included in this report as Attachment 1.

Facilities and infrastructure

Realize Flood Park

Construction of Phase 1 of the Realize Flood Park Project continues to progress. The small multi-use sports field, tennis/pickleball court, basketball court, sand volleyball court, expanded parking lot, and walking paths in the eastern segment of the park are scheduled to be completed in early November 2024 and opened to the public before Thanksgiving. Picnic and reservation sites, walking paths in the western segment of the park, and the meadows will open to the public in early 2025.

Community engagement for the Flood Park playground has concluded and the project alternative known as Boulder Canyon was selected as the preferred alternative. The Department is working with its consultants, CMG Landscape Architecture, to select the appropriate equipment and prepare detailed engineered plans for construction. The playground, which will be inclusive in design, will include a double tower with a bridge, spin zone, swing bank, double zipline, tot lot, interactive boulders and logs, and seating. Concept renderings of Boulder Canyon can be found on Attachment 2.

Tunitas Creek Beach

Amenities at Tunitas Creek Beach are starting to take form. The parking lot, ADA pathway to the midbluff, and overlooks have been graded; the restrooms and ranger station are being constructed; and the benches at the amphitheater have been installed. All hardscape is scheduled to be constructed by the end of October, with handrails, guardrails, and landscaping to follow. Substantial completion is scheduled for December 20, 2024. Depending on weather, Tunitas Creek Beach could be open to the public as soon as December 2024.

Throughout 2024, the Department has been engaging with the public to better understand what experiences people would like to have at Coyote Point. Based on feedback received, the Department determined that the public would like to see more built features in the park and have greater access to natural areas. A summary of the data collected can be found here.

As a result, two alternative concept plans were prepared for public consideration: an ecology forward alternative and an activity forward alternative. The ecology forward alternative focuses on landscape restoration and passive amenities that allow for people to connect with nature, like trails and picnic sites. The activity forward alternative focuses on building new recreational amenities, creating new opportunities to play, and enabling more community events.

San Bruno Mountain Day Use Improvement Project

At the August 13, 2024 Board of Supervisors meeting, the Board authorized an agreement with Romtec Inc. for the construction of the new day use area restroom and open-air interpretive pavilion at San Bruno Mountain for an amount not to exceed \$1,041,055. Construction of the facility is scheduled to start in spring 2025. In the meantime, the Department continues to work to upgrade the picnic sites and access paths at the day use area.

August 2024 Parks Commission Meeting Summary

The August 2024 Parks Commission meeting consisted of a site visit to Flood Park. During the site visit, the Commission walked the Realize Flood Park construction site and observed progress made on the subsurface utilities, walking paths, small multi-use spots field, tennis/pickleball court, basketball court, and picnic and reservation areas. The Commission also had a chance to see the pump track and how it is used by riders of all ages, abilities, and interests (i.e. bikes, scooters, etc.).





<u>UPDATE:</u>

On July 23, 2024, the Parks Department opened the Call for Grant Applications for the Fish and Game Propagation Fund. The Call for Grant Applications was posted on the Department website, included in the Department's August Newsletter, and emailed to partner organizations who may have been interested in applying for funds. The Call for Grant Applications was open for one month and closed on August 22, 2024. In total, five (5) applications were received.
