To the San Mateo County Board of Supervisors;

My name is Chris Rasmussen, and I am a Commissioner on the Mental Health & Substance Abuse Recovery Commission, Chair of the Children & Youth Committee, and a family member of someone who has experienced mental health issues and the juvenile justice system.

Every year, youth cycle in and out of the juvenile justice system and are held in the juvenile detention center. Many of these youth have lives that have been marred by poverty, violence, substance misuse, academic disadvantage, & delinquent behavior. Further, we know now that most of these youth suffer from a mental disorder, with a small percent experiencing conditions so severe that their ability to function is significantly impaired. Frequently, a youth's disruptive behavior is the result of a symptom of a mental illness that has gone undetected and untreated. For some youth, contact with the juvenile justice system is often the first and only chance to get help.

All too frequently, the opportunity to intervene early is wasted, and the youth end up in a system that is ill-equipped to help them, further traumatizing the youth and leaving the system overburdened. This crisis is real, and the need to respond is more pressing than ever.

I urge you to support the resolution in agenda item #14 for establishing a committee to modify institutional settings and examine the services at YSC for a more supportive environment.

I further urge you to include, on this committee, BHRS, a member of the Mental Health & Substance Abuse Recovery Commission, or a Lived Experience representative, to address the mental health needs of youth in contact with the juvenile justice system.

Dear Members of the San Mateo County Board of Supervisors,

I am writing in regard to Item 14 on the October 5, 2021 Board of Supervisors Meeting Agenda, the resolution titled "RESOLUTION DIRECTING THE COUNTY TO ESTABLISH A COMMITTEE TO EXAMINE YOUTH FACILITIES AT JUVENILE HALL AND MAKE RECOMMENDATIONS FOR A MORE RECEPTIVE ENVIRONMENT AT THE YOUTH SERVICES CENTER."

The Resolution reminds us that:

- Youth in the juvenile justice system have experienced disproportionate amounts of childhood trauma. It stands to reason that more trauma (time in juvenile jail) piled upon the prior trauma just increases the cumulative trauma.
- Mental health services are underfunded, and for inexplicable reasons it is much easier to obtain tax payer support for more jails than it is to fund the mental health services for incarcerated youth needed to help prevent recidivism.
- Living with metal furniture, walking concrete floors, and being locked in a cage when sleeping does not a restorative environment make. Is there an expectation that these young people will become more productive residents of the County in an environment such as this? Is there an expectation that they will become excellent students in reading and comprehension skills, math, social studies, history and science? You know the answers to these questions are probabilistically in the negative.

It is self-evident that the County is in need of a Committee whose purpose is to create plans to modify the current institutional setting at the Youth Services Center to make it a more supportive environment. And that some of the Committee members have the lived experience of being incarcerated in such facilities. Therefore, I ask that you support the Resolution.

**ACLU-North Peninsula Chapter Supports the Resolution Directing the County to Establish a Committee to Examine Youth Facilities at Juvenile Hall and Make Recommendations for a More Receptive Environment at the Youth Services Center**

Dear San Mateo County Supervisors,

On behalf of the ACLU-North Peninsula Chapter (ACLU-NP), I am writing to express our strong support for the resolution to establish a committee to examine the San Mateo County Youth Services Center (YSC) and make recommendations for a more rehabilitative environment.

The ACLU-NP is an all-volunteer group of community members that seeks to protect and advance the civil liberties of all residents, employees, and students in San Mateo County. We represent more than 4,000 people in San Mateo County.

If juvenile halls like YSC will not be abolished, our county should focus our resources less on incarceration and more on rehabilitation and preparing the youth to return to our community. Youth should be able to live in an environment that is designed to foster their return to society, not to dehumanize them. This committee should have the opportunity to examine, plan, and restructure the YSC to best serve youth who need support services to help them recover from substance abuse, mental illness, and trauma. We are heartened to see a requirement of two members of the community on this panel. For more than 10 years I led a nonprofit that took foster children and young people from juvenile halls in Merced and San Benito Counties to experience Yosemite and Pinnacles National Parks, and I have seen firsthand the healing impact of positive, nurturing experiences with adults for these young men and women who, often for the first time, experienced a supportive adult relationship outside the system. Meaningful change is possible, with a commitment from adults who are running the system.

Thank you to the Juvenile Justice and Delinquency Prevention Commission for this resolution to reimagine the system, and to Board Chair Canepa and to Supervisor Horsley for bringing this forward to the Board.
