The six of us commissioners want to submit the following letter officially to the Board of Supervisors ahead of their meeting next week:

Dear San Mateo County Board of Supervisors,

It was our honor and privilege to serve on the County's District Lines Advisory Commission. As you recognized at your November 9th meeting, we had to balance many different concerns and spent a great deal of time talking about these trade-offs before recommending the two maps. We took our responsibility to represent and speak for our communities of interest very seriously.

We, the undersigned Commissioners, therefore want to remind the board that a majority of the commission voted not to advance the Minimum Change Map suggested by NDC. We believed we had a once-in-a-decade opportunity to move away from the status quo, as told by the countless community members through public comment, social media posts, and private conversations. Both maps draw from extensive community input, and as you witnessed in your last meeting, have the community's support.

The Board is to be commended for creating the commission, emphasizing diversity, equity, and inclusion in the application, and recruiting a third party in the League of Women Voters to interview candidates. The Board of Supervisors must take the commission's recommendations seriously to truly acknowledge the much-needed change in San Mateo County. It is up to the Supervisors to take decisive action to set our County up for a more just future rather than a continuation of the past.

# Honorable David Canepa, President of the Board of Supervisors Honorable Members of the Board of Supervisors

I would like to thank you for the privilege of having served on the District Lines Commission. I would like to clarify that the letter which you received from the Commission Chair and two other commissioners recommending autonomy for the commission and adding supervisory districts were individual opinions. Without discounting the merit of either proposal, I am duty bound to point out that the commission neither discussed at length, nor voted on either concept.

I would like to offer what I hope will be construed as constructive ideas for future commissions.

## **Outreach**

Although we did receive a lot of public comment towards the end of the process, I think it was our most problematic issue. Contacting the public through the print media, city council comments and social media was a very passive approach. I suggest that for future endeavors the Board authorize the Health System or Human Services Agency to create a number of Extra Help or Term positions in the Community Worker position (or alternately assign permanent Community Worker employees) for six to eight months to actively reach out to the community to solicit input on the community of interest issue. These workers could reach out to community members in existing county settings (e.g., clinics), nonprofit and support groups for renters, veterans, and other hard-to-reach groups, faith organizations and various ethnic constituencies. The Community worker position is an agile classification that would easily adapt to this effort.

#### **Demography Consultants**

There were problems with posting two of the maps proposed by two of the commissioners that were rectified, but belatedly. I think naming the maps after individual commissioners also conjure up political allegiances in the community that don't belong in the process. Encouraging map proposers to name their map would help, or stick with numbered maps.

## **Overall**

I think overall there should have been a training or some discussion on how the final product would be developed and recommended. Many seemed unfamiliar with the various ways that maps could be discussed, ranked, and recommended which was detrimental in the end.

I favored bringing both the Espinoza map and the Unity map before you. Of the two, I wholeheartedly support what is termed the Espinoza map which I find to be fair, equitable and in keeping with the wishes of constituents in District 3 and throughout the county.

Honorable Supervisors and Staff,

The establishment of a redistricting commission is the first step in removing any politicization of redistricting. The second step is to follow the requirements as outlined in the Fair Maps Act of 2017. Specifically it states:

"To the extent practicable, the geographic integrity of any local neighborhood or local community of interest shall be respected in a manner that minimizes its division. A "community of interest" is a population that shares common social or economic interests that should be included within a single supervisorial district for purposes of its effective and fair representation."

Fair representation translates to equity. The word equity is used 20 times in the *Resolution to Advance and Improve San Mateo Racial Equity Efforts* unanimously approved. I was hopeful that there would be an understanding that **communities of interest** identify themselves rather than being identified by the establishment or a corporation.

Unfortunately, the Unity Map created by the Unity Coalition has been redrawn in a way that more resembles the Minimal Change Map and generally maintains the status quo. It is difficult to create an environment of racial and social justice when how we define ourselves is dismissed and changing the narrative is not part of the commitment.

Therefore, I urge you to use a lens of equity to validate the voices of the **communities of interest** and support the Unity Map revised by the Unity Coalition which is being sent to you in a separate email. A commitment to "advancing racial equity, belonging, and diversity in all aspects of County Government and program structure" is demonstrated when you lift up the voices of the communities of interest.
