Subject: Off Leash Dogs at Pillar Point Bluffs

I have resided in San Mateo County for 40 years, and for the last ten have served on the Advisory Council of the Monterey Bay Marine Sanctuary, which includes most of the littoral waters of the county.

Compared to other jurisdictions in the Bay Area and in the state our county does an abysmal job of managing the interactions of people, their dogs and wildlife. Pillar Point harbor and the beaches surrounding it have nearly constant off leash dogs on days ending in "y". Wildlife suffers greatly, as do people, conflicts abound. None of the local jurisdictions does anything other than shrug.

Last Monday at FMR a ranger removing a couple with an off leash dog from the closed area inexplicably failed to corral the violators as they passed two volunteers surveying harbor seals. They saw a camera being used to document the seals and savagely attacked, beating one volunteer about the face and head unconscious, so severely that the other thought her dead.

NOAA is planning a meeting with the pertinent law enforcement jurisdictions to better understand this problem. This incident demonstrates the county is not nor appears to understand how to manage the conflicts that result from multiple user groups accessing this area. More unsupervised off leash dog walking should not occur until how do manage these areas is understood. I am not against off leash dog walking, but it must be done in a way to not kill wildlife nor people.
