Dear San Mateo County Board of Supervisors,

I am the volunteer Co-chair of the ACLU North Peninsula Chapter and a Belmont resident. I urge you to pass an ordinance instituting meaningful civilian oversight of the Sheriff's Office.

Voters cannot make educated decisions in sheriff elections if they do not have information to assess the sheriff's performance. We need transparency so that we can make informed choices. AB 1185 gives you the power to establish meaningful sheriff oversight so that we can have that transparency and accountability. An Oversight Board and Inspector General would conduct independent investigations and keep the public informed about their findings.

To be meaningful, oversight absolutely must have the power to subpoen documents and question witnesses. And it must have an adequate budget to fulfill its mission.

Dear San Mateo County Supervisors,

I am the volunteer Co-Chair of the ACLU – North Peninsula Chapter, and I live in Redwood City. Please pass an ordinance to create an independent sheriff oversight commission and inspector general.

I am ashamed that my county's law enforcement agency acts in secret, supposedly policing itself. Sheriff's deputies killed Chinedu Okobi, and the Sheriff's Office delayed releasing their videos, maybe because those videos showed an unarmed Black man in crisis and the unnecessarily violent actions of the officers who killed him. And now Matthew Britton just died while under the care of the Sheriff's Office.

Whether in cases of clear wrongdoing by the Sheriff's Office, like when deputies killed Mr. Okobi, or in currently unclear cases, such as the death of Matthew Britton, an independent oversight commission and inspector general could investigate such cases independently and report their findings.


Please pass a strong ordinance to protect our community and make sure that the Sheriff's Office is transparent with and accountable to our community.

My name is Rita Giannini and I am a full time resident of Pescadero as well as a lifetime resident of Pescadero. I am writing this letter to express my concerns with the said project. I understand that the downtown area has a significant parking problem with the tourist visiting Pescadero as well as a problem with limited public restrooms. I do not think spending close to \$1,000,000.00 on a small parcel of land is money well used,

However, what is not needed is a plaza, a playground or other added on projects - really do we really need them? I think not.

My questions regarding this project

are:

- Who is going to maintain these facilities?
- -Who is going to patrol and monitor these facilities? You must know that we do not have a full time law enforcement agency here in Pescadero . We already have an issue with speeders racing on Pescadero Creek Road, Stage Road and North Street which creates a very unsafe situation for all of us.

Our local sheriff deputies have said that they are already limited and cannot be here full time to monitor this problem.

We also have a problem with trash, so who is going to be responsible?

Pescadero already has many opportunities for outdoor experiences- we have our beautiful beaches, a state park and a county park nearby which provide plenty of green space and fresh air for all to enjoy.

We also have a Little League field on North Street that is also used year round as a soccer field and baseball field by student's from Pescadero Elementary and also by families and children who are not part of the school community.

Just because there is funding available does not mean that all of it needs to be spent in Pescadero. I am sure that there many communities in San Mateo County that could put the monies to better use for well needed projects that would benefit all their residents.
