Media Information:

A Redwood City Police Officer conducted a proactive traffic stop on a vehicle for multiple moving and vehicle violations. Alejandro Beltran Millan (46), Oscar Magana (29), and Jaime Reyes Vargas (35), all from East Palo Alto, were contacted. During the initial contact, a handgun was seen in the glove box opened by one of the occupants. Additional officers arrived and the subjects were detained without incident.

A search of the vehicle revealed a total of two loaded handguns. One was a 9mm ghost gun (a privately made firearm that doesn't have a serial number). The other firearm was a Ruger 5.7 mm, which contained live rounds designed to penetrate body armor. Also located inside the vehicle was cocaine that was packaged for sale.

All three subjects were booked on various firearm and drug sale violations.

We commend these Redwood City Police Officers for their vigilance and their constant strive to keep our City as safe as possible.

Mr. Callegy,

Thank you for your reply. Might I suggest that once Supervisor Ray Mueller gets his office on the Coast set up, (where I understand he may offer the large space now only being used by the Sheriff's Activity League at Harbor to be used by other entities for their meetings) that the County could set up equipment there for some local public meetings, such as the MidCoast Community Council and the Coastside Design Review Meetings. Currently they had been meeting in a small, inadequately ventilated 3rd floor room where the Granada Community Services District has an office. I have attended meetings there (Pre-Covid), but it is inadequate in many ways: parking, seating capacity, sound quality (with the windows open the street noise & traffic drowns out the speakers) and now health as far as social distancing and ventilation are concerned. I believe there is a way the GCSD office may already be set up for public participation via Zoom, so perhaps someone from Planning could look into using that for the In Person Meeting Only on Thursday tomorrow so others can participate via remote at this meeting.

Subject: IN PERSON ONLY MEETINGS held by County Commissions or Committees

I am writing to object to the newest lack of transparency and limitation on public participation for meetings that are now being held without providing any means for the public to participate via a hybrid method, such as Zoom, as we have been used to doing during most of the pandemic.

Not only is it limiting for members of the Public to leave work in order to drive to Redwood City (From remote locations on the Coastside) simply to attend a SMC Parks Commission Meeting, held which are in the late afternoon, at 4:00PM, on the first Thursday of the month, but also, it is not a very green option even for Commissioners, or the public to have to drive to a meeting which has been held virtually all these past months during the pandemic.

In fact, most Special Districts have invested in providing remote participation despite the State's mandate to return to IN PERSON BOARD MEETINGS, because they see the value of continuing meetings held virtually via Zoom, which offer the general public an opportunity for GREATER PARTICIPATION.

Last Thursday evening, there was even a power failure mid-meeting, and yet, the Montara Water and Sanitary District Board was able to continue their meeting via back-up power on Zoom (albeit in a darkened boardroom.)

This week, on Thursday, there will be a Coastside Design Review Committee meeting which starts at 1:30PM in El Granada, that has been noticed as IN PERSON ONLY. One of my community members who lives across the Highway can not attend in person, due to her health and lack of a working vehicle. (She is 78) This puts her at a significant disadvantage because the subject proposed construction being reviewed, is adjacent to her home on Etheldore Street, in Moss Beach.

This sort of IN PERSON ONLY meeting is very limiting to those who work during the day, live a distance from the location of said meeting, or who are unable to attend due to age, health or transportation issues.

Why, when other SPECIAL DISTRICTS or COMMISSIONS (Like the Harbor District) were making ample plans to return to IN PERSON BOARD meetings (but with a public participation hybrid option) did the County choose to not prepare at all, and therefore limit public participation by that choice? This narrowing of the public's access and ability to participation should be addressed as soon as possible.

Full disclosure: I was recently elected to fill a Director's Vacancy on MWSD's Board, but I am speaking as a private citizen.

When I heard last night that Quarry Park would be closed for the next few days of storms, I drove up there today and I found what I was hoping for: another temporary stormwater diversion in place across the QP parking lot driveway. Parks successfully created this temporary solution in the January storm to relieve the residents "downstream" from QP in El Granada from the persistent and excessive flooding they had experienced in prior years' storms.

People and organizations do not always learn from experience, so I want to acknowledge Parks (Nicholas Calderon, Hannah Ormshaw, and staff) for learning about the stormwater problems in EG and having the initiative to take this necessary action without being asked.

Of course, it would be better if we had a permanent culvert/drainage solution in place so that we don't have to remember to install the temporary barrier and close the QP parking lot every time. I don't know what combination of DPW, Parks, Planning or other departments are required to create a more permanent solution. But it's good to see that Parks is proactively protecting the homes downstream of QP.

President Pine, Supervisors, staff and fellow citizens. I am County Commissioner Craig Wiesner and my pronouns are he/him. This morning my husband and I are speaking to a class on sexual ethics at Santa Clara University about our lives as gay men. We've been guest lecturers for 15 years. The most frequent question we get is "how can I show that I'm an ally to someone who is LGBTQ?" The thoughtful use of language is a huge start. By simply saying "my pronouns are he/him, they/them, she/her" what you're really saying is "you are welcome here - you are safe." Introducing yourself with your pronouns is the 21st Century response to what my mother taught me as a child. Be kind. Be respectful. Be inclusive. Last week I sent a care package of books, art supplies, and a personal letter to a trans teen who had attempted suicide. Might that attempt have been avoided if people around them had used their chosen pronouns? From peer-reviewed studies we clearly know the answer is yes. Suicidality is reduced by 65%. Thank you Supervisors for this resolution to be kind, respectful, inclusive, and helping to save people's lives.
