One can measure a society by how it treats its most vulnerable members and there are no more vulnerable than the undocumented and the incarcerated.

The justification for colluding with ICE has been that only the most violent felons are turned over to ICE. But what happens when violent felons, who are not undocumented, finish serving their sentences and are released back into the community? We have in place a system of support for newly released felons to help insure a more successful transition back into the community. There are halfway houses, parole officers, work programs, therapy and family support that can help ensure they are integrated back into society. These services greatly reduce recidivism and keep the community safer.

It is a travesty to turn them over to ICE. To send them to another country where they haven't lived for decades and know no one. To send them completely unprepared with no services or family support. They are much more likely to reoffend in these circumstances.

I am a member of the San Mateo County Coalition for Immigrant Rights (SMCCIR), representing the Peninsula Interfaith Coalition for Immigrants (PICI) and San Francisco Peninsula People Power (SFPPP). Hi, my name is Deni Asnis with Pacifica Social Justice.

As a retired public school teacher and a volunteer with the Youth Leadership Institute, I've worked with students in Pacifica public schools from elementary through high school and was able to see first hand the impact that the fear of family separation had on children and youth: young children reluctant to share their identities and family information because of realistic community fear of ICE, older youth experiencing the insecurity and disruption of threatened family separations, all due to ICE policies. It's hard to reassure young people when their County is itself a party to this threat.

I'm so glad that with the work of SMCCIR and San Mateo County communities, Supervisors Canepa and Pine have introduced an ordinance, supported by Sheriff Corpus, to keep families together and to permanently end the County's collusion with ICE. As a resident of Pacifica for over a decade, I was horrified to learn that San Mateo County still continued this abysmal unjust immoral practice. I, along with the majority of County residents, have supported ending it and am relieved that this can now be done. We're all well aware of the impact of COVID on children and youth, both in education and mental health. Funds are urgently needed to support youth in these areas. Dear District Attorney Wagstaffe,

To protect our youth and allow them a second chance, the San Mateo County Democratic Party (SMC Dems) passed this "[Resolution on Youth Tried as Adults](#)," urging you to stop the prosecution of our youth in adult courts. This resolution supports [Resolution 2022-02 on Youth Tried as Adults](#) passed by the San Mateo County Juvenile Justice and Delinquency Prevention Commission (JJJPC). As you may know, a number of speakers spoke to this issue at yesterday's Board of Supervisors meeting. The SMC Dems will be issuing a press release.

Scientific research shows developmental differences between youth and adults that impact decision-making, impulse control, and susceptibility to peer pressure. The prefrontal cortex, which governs the executive functions of reasoning, advanced thinking, and impulse control, is one of the last areas of the brain to mature.

As a result of this research, the Supreme Court has repeatedly recognized that youth are less culpable than adults and more capable of change and rehabilitation. The juvenile system is set to provide age-appropriate education, including basic and special education, as well as treatment and counseling services, and rehabilitation. This is important because many youth in the justice system have experienced or witnessed violence and trauma. Youth tried as adults are disproportionately Black or Hispanic, and youth in the adult criminal justice system face a higher risk of sexual abuse, physical assault, and suicide.

A delegation from the SMC Dems has scheduled a meeting with you on April 6 to discuss the problem of youth being tried as adults in San Mateo County.

Hello Supervisors and Mr Nibbelin,

As you can see in the attached screenshot of the public notice posted last fall on the SMC Parks Departments' website for Flood Park, smcgov.org/parks-realize-flood-park (click on "Learn more" and then click on the link to the Phase I Plan), the public was invited to attend the December 13, 2022 Supervisors' meeting to learn about the revised plan for Phase I. The revised construction plan is quite different from what the public has been expecting since 2015. This new plan was shown at a public input meeting hosted Nov. 4, 2022 in Flood Park that was attended by about 15 people. My husband and I along with primarily neighbors from our street, Del Norte Ave, that borders the eastern side of the park were most of the attendees. This meeting was also the first time the public was shown revisions made to the landscape design following a previous public input meeting in the park in June, 2022. Since we live adjacent to the park, what occurs there will directly impact our daily lives so most of the questions and discussion were focused on the landscape layout. The question was asked why the change in plan for phasing, but both my notes and recollection are fairly vague regarding the answer. Almost no time was spent discussing the change in the phasing plan. Therefore, we were looking forward to the presentation to the BOS on Dec. 13 about phases and attended that meeting only to find that the presentation had been eliminated from the agenda and the plan was passed on the Consent Agenda without discussion. There has been no following public discussion of the change in phases that I know of, but the public has invested a great deal of time and energy since May 2015 in following and influencing the plans for the park and deserves to know the rationale for this decision. It is possible that you, Supervisors, are also unaware of the changes and their implications for the use of the park during the several years required for construction. Basically, the baseball diamond/multiuse field construction will be delayed. Supervisor Ray Mueller has been aware of the evolving plans for the park in the past as a Menlo Park City Councilmember and likely has a personal interest as a resident of Menlo Park. It may be new information for Supervisor Noelia Corzo, but people from her district will also be using the amenities in the park so it's important for her to be aware of what they are now and what the new plans involve.

I strongly urge you to reschedul the presentation about the Phasing Plan. Whether or not any change occurs as a result of the presentation, at least you, Supervisors, and the general public will have had an opportunity to hear about it and ask questions, and the public will be able to view the video of the presentation if they are not able to attend the meeting.
