First and foremost, I want to express my appreciation for your dedication to public service and for taking the time to consider the importance of this matter. San Mateo County has shown dedication in addressing homelessness and housing, but more work must be done.

San Mateo County does not have enough affordable housing to meet the need and many families with special housing needs are priced out of the area or struggle with a high rent burden and inadequate tenant protections. Residents are seniors, farm workers, people with disabilities, unhoused community, veterans, domestic violence survivors, workforce working in retail, grocery, coffee shops, fast food workers, caregivers, childcare workers, support staff in our schools, low-income individuals and families.

The issue is displacement, housing insecurity or affordability, experience of the housing crisis with residents of San Mateo County. For the County to address the housing crisis, I believe we must prioritize the following recommendations:

Implement strong, research-based programs that address the needs of those with special housing needs. This includes those with disabilities, farmworkers, large families, workforce housing, supportive housing for the unhoused community and extremely low incomes individuals and families.

Rezone high resource areas outside of North Fair Oaks to higher densities to promote fair housing throughout the County and meet capacity for legally mandated affordable housing requirements. Affordable housing options should be spread throughout our county, including the wealthiest neighborhoods. Those communities cannot be discriminatory to affordable housing.

Include a commitment to update the County's Tenant Protections Ordinance, particularly with the addition of just cause for eviction protections stronger than state law.

We are in housing crisis caused by Cities and Counties throughout California failing to build adequate affordable housing in our communities.
