Good Morning to all Board of Supervisors,

A couple of meetings ago the BOS discussed comments regarding the Voter's Choice Act and voter ID.

With so many people questioning the validity of our elections I am appalled at the comments the board made in reference to doing away with Voter ID not only here in San Mateo County but, nationwide.

Additionally, I take issue with 4 more years the SOS just approved for San Mateo County to operate elections under the VCA, the plan includes directions that our elections must use voting machines, must have 10 extra days of inperson voting as opposed to one Election Day, must have numerous unattended drop boxes throughout the County, must allow people to vote in any voting center in the County. This is a recipe for illegal behavior.

The State & the County promote the Voters Choice Act (VCA) as "More Days, More Ways" to Vote. Many of us believe this creates an environment of "More Days, More Ways for bad actors to game the system". We need to ensure that our elections and processes here in San Mateo County are as secure as possible.

- 1. Doing away with electronic voting machines and tabulators should be immediately adopted.
- 2. Requiring every voter to show a valid ID (as they must do in every aspect of daily life such as; going to the doctor, opening a bank account, enrolling in school classes, showing up to work etc.).
- Opt out of the voluntary VCA and bring elections back to one day voting at the neighborhood precinct level. Creating a voting season and installing more drop boxes that have virtually no oversite, chain of custody or ballot supervision.
- 4. Standing against motor-voter auto enrollment. There is zero reason the DMV should have any role in our election process including asking people renewing or applying for CADL or CAID's to vote.

Refusal to adopt the 4 actions above would appear to be willful maladministration at best, malfeasance at worst. Please be advised that your decisions are doing more to create mistrust in our elections than you may think
