

Dear Members of the San Mateo County Board of Supervisors,

I'm writing this letter in support of the incredible work the Private Defender Panel provides on behalf of our most vulnerable citizens in San Mateo County. Far too often our court and jail system become the safety net for individuals struggling with complex mental health, complex medical health, severe substance use as well as socioeconomic issues that prevent them from hiring the same legal counsel afforded to those with means in our county.

Over the past three years the Private Defender Panel has expanded their ability to offer meaningful social work, follow up care, and client advocacy as part of the already stellar legal defense provided to clients charged with crimes that are a result of an untreated psychiatric condition or other psychosocial issue. As a result of the ongoing collaboration between the Private Defender Panel and Correctional Health Services at both Maple and Maguire Correctional Facility individuals spend less time in custody, are offered meaningful alternatives to jail, and prevent ongoing costs to the county without extensive court appearances and long jail stays. All of this provided with dignity and the professional level of service every citizen deserves not simply those who can afford it.

Dear Board Members,

I am a juvenile defense lawyer and an active member of the Private Defender Panel's Juvenile Division. I started my legal career at the Santa Clara County Public Defender's Office, a traditional indigent criminal defense organization and one of the best in the country. For the past 23 years, I have been in private practice and an active PDP member. During this time, I've seen every caliber of lawyer and I can say, unequivocally, that the highly-skilled juvenile specialists with whom I practice on the PDP Juvenile Panel are among the finest in California, consistently achieving outstanding results for our young clients.

PDP Chief Lisa Maguire and Juvenile Panel Supervisor Ron Rayes have instituted an array of cutting-edge programs that even the most highly-regarded Public Defender's Offices do not yet offer. And, they do this within a budget that comprises a fraction of the cost of a traditional public defender program. These include:

- 1. Robust pre-filing representation, including creation of social histories and safety plans within 48 hours of a minor's arrest. This makes an enormous difference at the critical "detention hearing" when a judge determines whether a minor is released to his/her family or kept in juvenile hall.
- 2. Post-conviction representation (e.g., record sealing, case dismissals) for all minors.

My name is Carla Gomez, and I am the new crim-immigration expert recently hired by the PDP. Prior to joining the PDP in mid-February, I served as a Senior Staff Attorney at the Immigrant Legal Resource Center (ILRC), where I focused on the intersection of criminal and immigration law, specializing in post-conviction relief for noncitizens. At the ILRC, I led weekly meetings with Padilla attorneys across public defender offices in California. I am well-acquainted with the volume of post-conviction relief motions filed by public defender offices, and I am particularly impressed by the statistics of San Mateo PDP regarding post-conviction relief.

Allow me to share the statistics from July 1, 2024, through the end of April:

PC 1172 (resentencing motions): 17 cases PC 1473.7 (vacaturs for noncitizens): 66 cases

PC 3051 (Franklin/YOP): 14 cases Sex offender relief: 10 cases Expungements: 519 cases

Dear Members of the Board.

I hope this letter finds you well. The purpose of my letter is to briefly describe my experience with the Private Defender Program over the past few years. In the summer of 2021, I reached out to the San Mateo County Military Diversion Court to learn more about the program and decide if a recent misdemeanor drug-possession charge would be best handled through this program or if I would be better off attending standard criminal court. It was difficult to compare my two options as I had never been put in a situation like this before, so I sent an email to Melissa McKowan, my assigned counsel through the Private Defender Program, expressing my hesitation to move forward. Later that evening, I received a reply from Ms. McKowan, and I was shocked to see how long of a letter she had written me. She described, in painstaking detail, all of the benefits of joining the Diversion Program, and thoughtfully answered every single question I posed in my initial email. Her letter quickly eased my concerns and convinced me that the Military Diversion Program was indeed the better of the two options. My decision wasn't solely based on the content of her reply; rather, it was evident how much she cared for me, someone she had yet to meet, by taking the time out of her extremely busy day to write such a thoughtful and in-depth response. Something told me that if I joined this program, I would continue to receive the same level of support - and I was right. From that point forward, Ms. McKowan consistently took the time to keep me informed of my case and quickly responded to my questions, both day and night. Her decades of experience and astute knowledge of the law comforted me in knowing that I would be extremely hard pressed to find better counsel on my own, anywhere. Although she was responsible for representing numerous veterans at any given time, I can truthfully say that I always felt like a priority. I felt cared for, and that meant the world to me during that time of my life. And it seems I wasn't the only one - upon meeting some of the other veterans in the program, I heard them express very similar sentiments.

I am extremely grateful and blessed to have had Ms. McKowan by my side during my time in the Military Diversion Program. Although I graduated from the program last year, I still attend the monthly sessions serving as a mentor for other veterans.
