This email communication is our public comment to urge the Board to add the Redwood House closure situation to their 11/19/24 meeting agenda.

As you may have heard, Caminar's Redwood House (248 Redwood Ave, Redwood City) is scheduled to close by 12/31/24. This facility has been a cornerstone of mental health support in our communities for over 60 years and is the *only* Crisis Residential Program serving San Mateo County. They support people who've gone through a recent mental health crisis to further stabilize and get connected to needed resources. They are closing despite solutions proposed & funding being available, at the expense of SMC residents in critical need of services, and at a time where beds in SMC BHRS facilities are very limited and some individuals must even be placed out of County in unknown environments away from relatives.

Since its creation over 5 years ago, Heart & Soul Inc's H.O.P.E. Program has successfully been partnering with Redwood House - the SMC BHRS facility providing the most referrals for our unique transitioning program from acute to lower level of care and back to the community. Together with Redwood House dedicated staff, we are making a real difference not only by supporting residents' recovery toward independence but also by reducing rehospitalization throughout the County.

Thank you for your consideration and making the Redwood House closure situation a priority and agenda item for your 11/19/24 meeting.

This comment is for a matter not on the agenda, but I am urging the board to add this subject to their upcoming agenda. I am reaching out from Caminar's Redwood House, the only crisis residential treatment program in San Mateo County, and its scheduled closure on 12/31/24. I am requesting emergency action to be taken by the board to extend the current contract held by Redwood House until an agreement is met between the Caminar Board and Behavioral Health & Recovery Services (BHRS). This program provides invaluable services to San Mateo County and its population experiencing SMI. Without it, this population will not receive the treatment that it needs to manage their diagnoses. We will see an increase in homelessness and hospitalizations as these clients lose a pillar of their recovery path. Other programs will be impacted by the loss of Redwood House, as many clients will stay longer at the hospital or enter programs that they are not prepared for. If the goal is to improve the treatment of this population, keeping this established and well-run program alive will meet that goal. Letting it close will create a substantial problem for the county meeting its legal requirement to have at least one CRT program, as well as posing a risk to the health and lives of the folks who need our program. This is a problem for a deeply underserved and underrepresented group of people, so I will speak on their behalf: keep Redwood House open!

#### Below is my statement:

"On October 21, 2024, Caminar CEO Mark Cloutier announced the impending closure of Redwood House, a Crisis Residential Facility in San Mateo County, set for December 31. This vital mental health support center, operating since 1964, is the only Crisis Mental Health Program in the county, offering an alternative to hospitalization for individuals experiencing acute psychiatric symptoms. Its closure would risk the well-being of countless community members, amplifying pressures on already overwhelmed social services. We hope this decision can be reversed. Redwood House has been a lifeline, providing 24/7 care in a safe, home-like environment that promotes stability and independence. For 60 years, its personalized treatment plans, life skills training, and harm reduction approach have empowered individuals to recover and reintegrate into the community. As a former counselor at RWH, I witnessed firsthand the profound impact of our services on the lives of our seriously mentally ill population, serving as an essential linkage between psychiatric hospitalization and stabilized reintegration into the community. Losing this resource would exacerbate mental health crises in our community, especially as homelessness rates continue to climb and over 146,000 adults in San Mateo County face mental health challenges annually.

The stakes are high. The closure of Redwood House will lead to higher rates of homelessness and incarceration. Approximately 70% of individuals booked into San Mateo County's correctional facility struggle with addiction or mental illness, and displacing Redwood House residents could further strain emergency services. Redwood House is a lifeline for recovery, ensuring that residents are never discharged to the streets.

The closure of RWH would deprive mental health consumers of essential support and care and force vulnerable people back into environments ill-equipped to meet their needs, increasing the risk of homelessness, hospitalization, and involvement with law enforcement. This closure would not only disrupt individual lives but erode the fabric of our community's mental health safety net, further straining an overburdened social service system.

We cannot afford to let this vital resource slip away. We must stand together to preserve RWH and continue providing compassionate, effective care to those who need it most."

Clients come from hospitals, locked units, and jails from all over the Bay Area & even out of county.

Its closure would jeopardize the mental health of countless individuals and strain our already overwhelmed social services. The cost of people cycling through the hospitals & jails will be larger than the resources needed to sustain the program. Out of county hospital beds cost thousands per night, whether it's occupied or not. The beds at Stanford Hospital cost 10k per night. Additionally, the rate in homelessness would increase as no client that goes through Redwood House is discharged to the streets & is always given a placement!

However, according to Dr. Jei Africa, the decision can be reversed! This program has a legacy within the community and is the flagship program of Caminar. I'm hoping the board can encourage the Behavior Health & Recovery Services to extend Caminar's current contract until a viable solution is agreed upon.

Although Cordilleras is being revamped, not everyone in crisis meets the criteria of being in a locked unit. Also, what resources will people be connected to once leaving a locked unit if Redwood House closes? We know that without a step down for reclamation, there is higher likelihood of re-hospitalization.

I am urging the board to add this to the agenda for the 11/19 meeting.

Dear Board of Supervisors-

First, thank you for taking the time to review this report and consider all the public comments. My name is Jacqui Cebrian. I've been a resident of the Belle Haven neighborhood of Menlo Park for 16 years, a teacher at Oak Knoll for 21 years, and a member of the Menlo Park Complete Streets Commission for 5 years. I've been bike commuting for about 6 years from the bayside of Menlo Park to the Oak Knoll neighborhood. I do this during our peak traffic window in the morning. Over the past 6 years, the city of Menlo Park has done a great job of adding marked bike lanes on high traffic corridors and it has dramatically reduced the stressful sections of my ride. That makes the impending disaster of Ringwood stand out all the more and is now THE most dangerous part of my ride and the part that I can almost be assured of having a car not see me while they get to where they are going. The bad car behavior you are surely hearing about from parents riding with kids is all true, and also just scratches the surface.

Our planet is warming and we all know that traffic is regionally driven and congestion is a fixed feature of our roads unless we can get more people to choose something besides to travel our city streets. Not everyone can ride bikes to work/school, but not everyone who is driving needs to be. This means that the number of bikes on the road during commute times right now is the smallest number you're going to have. More bikes are coming and nobody should have to go to the hospital or worse to get action when the city and the county are fully aware of the issues.

Streets are a public resource - not a private right of way. A handful of residents shouldn't be able to prevent a much larger number of road users from having a safe route when you have to power to make it happen.

I urge you to listen to the feedback and try the one way pilot program in coordination with Menlo Park's effort to install bike lanes on it's portion of Coleman. But also, and equally importantly, I urge you to look at long term solutions for Ringwood and then start putting the wheels in motion to ensure that everyone who uses those high traffic corridors has a better chance of getting where they are going safely and without the stress of trying to fight for space with cars.

This problem has been going on for years. You're hearing about it now because our cyclist population is growing - as it will continue to - and they vote also. You are tasked with looking at all the available information and making a decision that benefits the greater community. Everyone deserves safe streets and we are years overdue for this section of roadway because of the mutli-jurisdictional complications.

Please take meaningful action on this report. It's why you were elected to your positions.

Subject: Expansion of Mobile Crisis Response Teams for 911 Calls

Dear San Mateo County Board of Supervisors,

I am writing to express my support for the expansion of Mobile Crisis Response Teams (MCRTs) in San Mateo County and to urge their integration into the 911 dispatch system for calls regarding "strange behavior or activities."

The recent soft launch of the SMC 24/7 MCRT program, with five teams now operating countywide, is a commendable step towards addressing mental health crises. However, I believe there is an opportunity to enhance this program's effectiveness by following the successful models implemented in other cities, such as Denver's STAR program.

Currently, MCRTs are dispatched through Star Vista's crisis line or 988, which is beneficial for individuals experiencing a crisis or those personally connected to them. However, this system overlooks a crucial scenario: when a bystander observes someone exhibiting mental health issues and calls 911.

To address this gap, I propose:

- 1. Expanding the MCRT program to handle more calls across the county.
- 2. Integrating MCRTs into the 911 dispatch system for appropriate calls.

3. Training 911 operators to identify situations where an MCRT would be more suitable than traditional law enforcement.

These changes would ensure that trained mental health professionals respond to nonviolent behavioral health calls, potentially reducing unnecessary police interventions and improving outcomes for individuals in crisis.

I urge the Board to consider these recommendations during the upcoming presentation on November 12th. By enhancing our MCRT program, San Mateo County can become a compassionate, effective crisis response leader.

Please close this gap in service so more people can get appropriate and timely help.
