I am concerned about San Mateo County's glacial easing of restrictions. While the rest of California is moving forward, we seem to be at a standstill in comparison. Los Angeles, which has more than half of the state's COVID-19 cases, has opened hair salons/barber shops with gyms and bars resuming business next. How are we falling short? Available data does not support a decision for ***continued heavy restrictions***. Hospitalizations have stabilized. No deaths yesterday. An increase in cases is most likely a consequence of protests. It is time for SMC to reopen more businesses alongside the rest of the state and still manage the risks. We, as caring citizens, will shoulder this task with the most noble of intentions, in compliance with mandated guidelines and for prevention of the virus. I urge you to support and transmit attestation for variance to the CDPH today. I look forward to Dr. Morrow's revised SIP order advancing the county through Stage 2.5 in the next week, and headed toward California's Stage 3 reopening plans by the end of the month. ***San Mateo Strong.***
