To the Honorable Board of Supervisors of the County of San Mateo:

I am writing to you today as a County employee of nearly 15 years, as a woman over the age of 50, as someone who is considered to have likely contracted COVID-19 in February of this year and can attest to the devastating symptoms it presents, as an American-born citizen who has experienced being uninsured, underinsured, and unable to afford insurance in the past due to pre-existing conditions, and as a person who hopes to continue providing healthcare services to others in the County of San Mateo for many years to come.

I have had friends and esteemed colleagues who work for the City and County of San Francisco and for the County of Santa Clara try for years to get me to leave San Mateo County to instead work for their respective counties. One of the arguments they have often used to try to lure me is that I would be provided with lifetime medical care at retirement. I hold loyalty dear, so I have not taken any offers of employment that I have received from these other counties or private entities (such as Kaiser and Sutter Health) because I believe the County of San Mateo can still do great things.

The next thing that we need to achieve is a REAL and EQUITABLE retiree healthcare plan for our employees that does not punish those with children, those with sick or ailing family members, those with chronic health conditions, and those who fall ill through no fault of their own such as I did earlier this year at the beginning of this pandemic. Because I was so ill with COVID-like symptoms, I stayed home three full days (a record for me) attempting to recover from what I believed was a flu at the time, but it did not improve. Because I was fearful of losing valuable sick leave that I need to pay for healthcare one day, I returned to work after three days off and now realize I returned prematurely. I was symptomatic and coughing for three full months after the fevers and other symptoms subsided. This I realize now was not a safe choice, but I felt I had no choice at the time.

Please, PLEASE strongly consider the Labor Retiree Healthcare Proposal we are presenting to you. We are willing to pay into the plan 2% of our own salaries to ensure we have viable healthcare after we retire, and the plan will save the County of San Mateo \$3 million annually. It is a win-win for everyone involved.

Thank you for your consideration and for doing what is best for the employees who take care of the citizens of this County that I work for, live in, pay taxes to, and cast my votes in.
