To Whom it May Concern,

Please see below for my questions regarding Agenda Item #1 (Towneplace Suites in Redwood Shores) for this afternoon's meeting at 3PM. Note that I have asked 90% of these questions in the past with no answers as of yet. I generally avoid politics, but I am sincerely displeased with the County's lack of answers to my questions on this, as well as the County's decision to ignore Redwood Shores voices and move forward with this purchase.

- 1. I am not personally against helping elderly stay on their feet, but the language of the affordable senior housing does not preclude the County from providing housing for others as well (mentally unwell or addicts younger than 62, for example). How will the County ensure that only age 62+ low income seniors are accepted at this permanent housing for the lifetime of this facility? As noted at the meeting on 12/18, only 1% of the low-income population is 62+.
- 2. What happens when the operator of the facility evicts a resident? How will the County of San Mateo ensure that Redwood Shores not be filled with homeless encampments along our protected trails and levee?
- 3. How does the County plan to provide funds to Redwood City police to add patrols proportional to the added population? Currently, Redwood City struggles to patrol RWS as it is, and in some cases, even has the CHP come help patrol on their behalf.
- 4. County of San Mateo should also be including the City of San Carlos within these discussions, as the nearest downtown is SC, and the hotel is immediately adjacent to the San Carlos boundary (San Carlos Airport).
- 5. What happens if we call 911 to report someone struggling to walk at the 101 interchanges at Redwood Shores Parkway/Holly? I have called 911 to report an incident at this overpass, and got all the way home 2 miles into RWS before I finally got someone on the phone-too little, too late to resolve what I had observed. I got bounced from RWCPD to San Carlos PD and even Belmont PD. This is a problem that needs to be resolved before elderly are placed nearby. I am extremely concerned that there will be elderly walking across this dangerous overpass and getting hit by vehicles.
- 6. What protections will be promised for the levee during the remodel? How will the operator ensure the levee stays safe in order to continue to provide protection from future floods?
- 7. How will parking be handled? How many residents will be permitted to have a car?
- 8. What other hotels submitted their applications late to this process, and can the County re-evaluate priority hotels? I believe if you evaluate and include other hotels, you will find other locations more amenable-for example, the other hotel in Redwood City has not been causing any complaints from the neighbors as far as I have seen. Additionally, while these two locations have been bragged about as amazing, these are literally the only two hotels who submitted their paperwork on time. That should not be the reason they are selected, just because none others were available.
- 9. This should not be considered part of project Homekey. Project Homekey is described as providing homes for the homeless. As described in the 12/18 meeting, this is NOT a homeless shelter, but for those with low incomes who cannot afford regular apartments and such (aka Affordable Senior Housing). Since it's not really applicable to project Homekey, this hotel purchase should be put on hold, re-evaluated, and brought forth with the correct approval process (neighborhood meetings, City Councils providing fully vetted opinions, etc.).

- 10. Why has the County not provided RSCA with all of the answers to the community's questions, as the County had promised at the meeting on 12/18? It appears that by providing a delayed response until the DAY of the purchase (12/1) at this 3pm meeting that not many can attend (I just heard of it this morning and thankfully have no work conflicts), we do not have a chance to provide a rebuttal or pose additional questions.
- 11. I understand that the money for this hotel will be provided from existing funds (project Homekey and another County of San Mateo fund). Once it is operational, how will the County of San Mateo ensure that our property taxes will not be raised in the future to pay for this facility that we did not ask for?
- 12. I understand that those with past drug addictions or mental problems can technically label themselves as disabled, and therefore cannot be restricted from living at this facility. With that in mind, I do not think that having this facility immediately adjacent to a childcare center and the Bay Club (with many children attending daily) is wise.
- 13. There was an article (https://www.smdailyjournal.com/news/local/san-mateo-county-eyes-new-shelter-models/article_aff083f4-24a3-11eb-85cf-db1fbbfb39cb.html) in the SM daily journal mentioning the purchase of multiple modular housing units to be placed on a property in Redwood City, which includes potentially 150-200 units. Why purchase this Redwood Shores hotel when these units can be used on an empty lot in a mostly industrial area instead? The property is also closer to downtown Redwood City, the CHP, and the Redwood City police department.
- 14. Will there be an increase in bus service to accommodate the added population? Will the buses provide a lower fee to these residents so they can afford to use the bus?
- 15. Please stop using COVID in the language of this Hotel purchase. The Hotel purchase is permanent, COVID is not, so they are not related. This is project Homekey, not Roomkey. Project Homekey should have less stringent deadlines. I understand that (based on an article I read on 11/18 in the SJ Mercury News), Governor Newsom plans to continue to provide funds to project Roomkey in 2021 so that the temporary COVID housing in hotels for the homeless may continue through the COVID crisis. Meanwhile, this allows local governments to have more time to select the permanent housing options via Project Homekey.
- 16. I am writing not to address the issue of housing the homeless in Redwood City hotels but to point out your continued lack of engagement and transparency with the Redwood Shores community about Project Homekey. It's apparent you will hastily approve the property purchases today, completely disregarding the questions from the community. In particular, Supervisor Slocum hasn't bothered to engage his district residents though I do want to acknowledge Supervisor Pines for at least trying to answer our concerns.

Over 200 residents participated on your Nov 18 zoom meeting where few questions were answered. Over 100 questions were submitted prior to and 300 during the meeting, and they remain unanswered. I am writing to reiterate concerns about the proposal that, along with many other important items recently, cropped up with INSUFFICIENT NOTICE to the community and INSUFFICIENT PLANNING or detail sharing.

The concept of providing additional housing for those in need is to be applauded. The process and followup plans need work.

In addition to concerns about lack of community dialogue, and lack of logistical details provided, I'm concerned with what (if any) on-going services people will have access to, and how the sites will be maintained for its residents in the near and long term. So what will they do throughout the day if they are not working? This is wrt to the FAQ found on Homekey site below (Q) which says they can use vouchers.

Q: Our community has many unused Tenant Based Rental Assistance (TBRA) Vouchers (from a variety of state and federal programs), which are assigned to people experiencing homelessness. Many voucher holders have not been able to find housing but Homekey acquisitions could change that. These vouchers would support operations and the services. Could we count these TBRA vouchers as part of our match? If so, how can we demonstrate this in the application?
