

Dear San Mateo County Board of Supervisors,

We, concerned families and community members of San Mateo County want to bring your attention to the negligence and inhumane treatment of people incarcerated in the county jails. Through our minimal communication with our loved ones, we have heard of multiple causes of concern about how jail staff and the Sheriff disregard basic health precautions to the detriment of our loved ones. To name a few: people are not tested upon release, many people released from custody are not connected to community resources, and many CO's refuse to wear masks or gloves properly.

It is only natural for families to worry about their incarcerated loved ones especially as COVID-19 cases continue to increase. The heightened risk of COVID-19 in jails and Sheriff Bolanos' unwillingness to respond to family concerns adds stress and anxiety. The Sheriff's office has taken a passive approach by denying people visitation and not providing family members with information on COVID protection.

At the start of the pandemic, Sheriff Bolanos immediately discontinued all in-person, behind-the-glass visits. For months, families were faced with a choice: not talking to their loved ones or facing the financial costs of texts and calls. In June, the Sheriff introduced video visits as a replacement for in-person behind-the-glass visits. While the option for free video visits was an improvement, the implementation phase has not only been challenging for those without proper electronic devices but the constant technical issues make it frustrating.

For example, in one family's experience, logging into the video visits is continually challenging. Sometimes, even if both people are on the line with perfect internet, it will show a loading screen for the entirety of the 30 minute visit. Regardless of whether the video actually works properly, there is no opportunity for people inside to reschedule a visit and when help is requested from CO's, they don't have the technical skills to assist.

When families have contacted the jail to resolve these issues, jail staff redirects families toward the company that provides the service. However, this results in lack of responses often sending families back to the jail and neither one can take responsibility. After six months of implementation of video visits, there are still major downfalls to this system, which the Sheriff has refused to deal with.

The major significance of this issue is the effect that physical and emotional isolation can have on our loved ones. As families, we know that family contact and fostering relationships with people back in the community is integral to the rehabilitation of our loved ones. Keeping regular communication with their significant others, children, parents and other support systems gives them an incentive to fully rehabilitate and complete their time to reintegrate back to the community upon their release.

Given the major technical issues with video visits, as well as the months-long physical and emotional isolation of our loved ones inside Maguire and Maple Jail, we are demanding in-person, behind-the-glass visits to be reinstated. Prior to COVID-19, the in-person behind the glass visits process had limited exposure for jail staff. There are glass windows separating physical interaction, and if indeed, jail staff are following health provisions, COVID-19 exposure due to in person visits should not happen. This simple solution will not require additional personnel or fickle technology, and will eliminate the added burden on jail staff to answer the insurmountable questions from the public and families.

Families are mindful that if in-person visits are restored, the same precautions recommended by the CDC should be followed including wearing masks, social distancing, and proper sanitation. There is a precedent for in-person, behind-the-glass visits in the federal prison system during the pandemic. County jails in both Santa Clara and Sutter County have found a way to accommodate, in-person, behind-the-glass visits during the pandemic. Especially as San Mateo is staying open longer than other counties, why do our community inside the jails and us, the families, get denied family visits during COVID while restaurants

While the Sheriff has done the bare minimum, there are many families who have questions related to their loved ones' health and the Sheriff's ongoing response in light of COVID.

Questions for the Sheriff:

- Public Information about Jail Population and Covid-19 Cases
 - At the beginning of the pandemic, the Sheriff was publishing monthly reports about COVID-19 infection and updated population numbers in the jail. For the past few months, these reports have stopped, along with any information about COVID-19 infection in the jail.
 - When will the Sheriff's Office resume publishing information about COVID-19 and population numbers inside the jail?
- What are the efforts in reducing the jail population and reconsidering release of people?
- What are the plans for distribution of the vaccine?
 - When are people incarcerated in county jails going to get access to a vaccine?
 Will they get access before people on the outside because of the proven health risks of incarceration?

- Is programming going to be continued when people inside are vaccinated?
- Public Information on MOU between Sheriff and CDCR
 - Families have attended state public hearings where CDCR (California Department of Corrections & Rehabilitation) has shared that each county has an MOU for keeping people in county jails. Is this information accessible online for the public? If not, from whom can families request this MOU?

We, as the families, have the best interest of both the community and our loved ones inside and want to work together with the San Mateo County Board of Supervisors and the Sheriff's office to make sure that our loved ones are healthy and connected to their support systems during their rehabilitation. People who are currently in our county jails are a part of our community and should be included in conversations about public health in San Mateo County.

RE: Acquisition of the Coastside Inn in Half Moon Bay for Transitional Housing

Honorable President and Members of the Board:

I am writing on behalf of the City of Half Moon Bay. Homelessness has been a long-standing priority for the City Council, yet a very challenging issue in Half Moon Bay. The Coastside of the County has a higher percentage of homeless individuals when compared to the rest of the County, yet many of the necessary services are not on the Coastside. Additionally, trending numbers show that positive COVID-19 cases are higher on the Coastside than the County average.

The City Council is supportive of this acquisition to purchase the Coastside Inn and very appreciative that the County is pursuing this unique opportunity afforded by the CARES Act. The City held two public meetings on November 19 and December 1, 2020 to discuss this proposal with the community. The Council wants to specifically acknowledge Supervisor Horsley, County Manager, Mike Callagy, and the Human Services Agency Director, Ken Cole, for attending these two meetings, presenting the proposal, and answering questions from the Council and public.

Addressing homelessness is one of the most vexing challenges of our time, and part of the challenge is the community stigma attached to these individuals—human beings—who have found themselves without basic shelter. At the December 1, 2020 meeting, over 200 community members attended the meeting and 60 people spoke. While many people were in favor of establishing transitional housing in Half Moon Bay, many had concerns and questions, and many were outright opposed.

The City Council prides themselves on serving *all citizens of the City* and they are grappling with the opposition and community concerns. They want to break the stigma of homelessness, address the concerns of the community members who are opposed, and ensure that this facility is successful in the long-term.

To do that, the Council and community are requesting some commitments from the County. Specifically, they are requesting the County consider and commit to the following:

- Reimbursement of the financial loss from removing a hotel from the tax rolls (there is a huge loss to the City of Transient Occupancy Tax but also property tax and sales tax to a lesser extent)
- City participation in selection of the operator and design of the program(s). The "short list" of potential operators would also make a public presentation before final selection is made
- City and community ongoing involvement to ensure success of the facility and associated programs
- The use of local non-profits and businesses to provide support and services
- A clear commitment by the County to prioritize City residents and Coastsiders in the facility
- County assistance in remediating and restoring abandoned homeless encampments
- Comprehensive and reliable background checks that will screen out potential program participants with violent criminal backgrounds including assault, battery and sex crimes involving either children or adults (including Megan's list).
- County, in consultation with the City, to draft a plan to turn the facility into
 permanent supportive housing or deed-restricted Below Market Rate housing for
 low-income individuals, or co-housing, or workforce housing within five years
 from the date of the issuance of a certificate of occupancy.
- A plan for appropriate disposition of the facility should the program not be successful as originally envisioned

The key to these commitments is that the success of the facility is dependent on partnerships: between the City and County; the service providers and the City/County; the facility residents; and most importantly, the community. The commitments listed above, while not exhaustive of all concerns and program details, were the essential themes at the December 1, 2020 meeting and many people spoke to the need for a written document that consummates the partnership between the County and City. The City Council requests that a Memorandum of Understanding (MOU) be developed and

approved by both agencies that establishes roles, responsibilities and the commitments summarized above. The City and community want to ensure the facility is successful: a facility that breaks down the sigma of homelessness and is a source of pride for the Coastside.

SMC and HMB elected officials,

The proposal to purchase the Miramar hotels and convert them into homeless housing has raised a considerable amount of concern across the Miramar neighborhood and Coastside community. A government of the people, by the people, and for the people is the cornerstone to our way of life. This plan to drastically change the community of Miramar, without local input, is wholly un-democratic and represents government overreach, plain and simple. Please show the following at a community meeting and through the local paper ASAP to increase transparency immediately.

- Show how this plan does not affect HMB local budgets and the city's ability to financially recover from the COVID-19 economic downturn. How does the city make up for this loss in revenue opportunity? How does it make sense for SMC to remove revenue streams from struggling municipalities during a pandemic induced economic downturn? SMC should help, not hurt. HMB city budget is at a breaking point.
- 2. What is the long-term plan to fund this operation post SMC purchase? Is this going to be another unfunded liability that will require additional taxpayer funds in the future?
- 3. Please show the efficacy of this plan on the outcomes of homeless populations and support this with clear data and evidence.
 - a. Explain how an ocean hotel, in a residential area, with minimal services within walking distance, can be helpful to a homeless population with limited means of transport.
- 4. Along with #3 what is SMC's master plan to address homelessness? Is this part of that plan? Where does it fit in? Prove that this is not a knee-jerk reaction to a CARES ACT spending deadline.
- 5. Along with #3a and #4, explain how Miramar is an appropriate location for this land usage.

 Transportation options? Medical care options? Grocery options? Please show how this location suits this use.
- 6. What other items / activities can be done with CARES ACT funding? Local school improvements? Local municipality shortfall assistance?
- 7. Last but not least, community SAFETY. Miramar is a small residential community. What community impact study has been done? What plans are in place? A quick search of anecdotal evidence shows severe impact on crime rate in areas with these projects. How does SMC plan to address this. Families live here, children live here, grandparents live here, WHAT IS THE PLAN?

If there is not a well thought out plan, and this is a knee-jerk reaction to a spending deadline, do not spend the money, full stop. Don't hurt HMB, Miramar, and the Coastside with half baked governance.

San Mateo County Board of Supervisors -

I am writing today to formally state my opposition to San Mateo County purchasing the Coastside Inn in Half Moon Bay for the purpose of sheltering the homeless. We are a small community that lacks all of the resources necessary to sustain this type of service for the homeless. Most importantly, we have no hospital, limited sheriff/police officers, no drug or alcohol interventionists, overwhelming traffic and gridlock in case of an emergency, and the area lacks sufficient entry-level job openings that those in transition to housing require to sustain themselves. Who gets the <u>one</u> ambulance we are guaranteed on the Coast when there's an emergency - someone OD'ing in a homeless shelter or someone having a heart attack at home? You have promised wrap-around services but have given no details or guarantee of funds.

We are also losing tax revenue. What about our Main Street businesses who will lose more revenue when the tourists stop coming because HMB has become a dumpster like Santa Cruz? Who will make up this lost revenue? Who will reimburse property owners when their property values inevitably decrease because of an increased homeless presence? Who will be left holding the bill when "promised" county funds don't come through or end? Our small town is already crippled with debt. We simply can't afford it.

The Coastside Inn is within 2 blocks of 3 schools (Hatch Elementary School, Cunha Middle School, Pilarcitos HS) and the Coastside Boys and Girls Club. This is not an appropriate location for a homeless shelter that provides no services to families in need and that potentially will lead to additional homeless encampments in the surrounding blocks. Young children walk to school in this area and their safety is of utmost concern. I have a 4 year old and 7 year old. I don't want them walking around dirty needles, drugs, trash, increased crime, etc. This is not hyperbole - I work in downtown SF and my husband grew up in Santa Cruz. We've seen first hand what happens when you invite homeless into the community with promises of services... the population will grow exponentially. I refuse to allow the community I grew up in become the disgusting homeless havens that SF and SC have become. Increased crime, increased drugs, increased homeless presence. Is that that picture we want for tourists- the main revenue source for HMB? Mr. Horsely even admitted during your last meeting that there will be increased crime and promised additional sheriff services. You are literally knowingly bringing crime to a small community.

While it's been stated that local homeless will allegedly be given preference when allocating housing, I fear that additional homeless will be brought into our small community to fill the shelter and be a further drain on our limited resources. There have also been no assurances of background, criminal record or sexual offender checks. This housing would essentially assemble a large unknown and unpredictable population in the midst of our largest group of vulnerable youth on the coast. Would you want your kids going to school next to a homeless shelter? Would you want this in your neighborhood, literally across the street from your young children?

There have been no studies, no formalized plans, no community outreach to the people of the Coastside. Will you listen to those who elected you into office?

I urge you to consider the overwhelming amount of community opposition to this purchase and I reiterate my vehement opposition. Look at the 2 opposing change.org petitions- the group in opposition to the purchase is leading by an almost a 9:1 ratio. While some of the supporters are the most vocal people on the coast, the overwhelming majority of citizens oppose this. The Coastside already has limited resources and this proposed shelter will disproportionately pull resources from the rest of our tax paying and voting community. You were elected to represent us and our interests. This is in direct opposition to your constituent's wants. Do the right thing and let Coastside residents know that you care about them and don't just represent people over the hill. We do not want a homeless shelter in our community and formally oppose the proposal.

Subject: Half Moon Bay Coastside Inn purchase

All,

First I would like to thank all of you for your tireless, often unrecognized effort to make this county a better place to live in. I truly do appreciate civil servants, and people that work for the city, county, state, country.

I am typically not a very political person, but find it necessary to voice my concerns over the recent proposal to buy the Coastside Inn and convert it to "transitional housing".

I have many concerns, but the primary one, would be the one of safety for our local schoolchildren.

The Coastside Inn is about 1,000 feet from Hatch Elementary School, Cunha Intermediate School, and the Boys and Girls Club of the Coast. My own daughter frequently walked to school from our neighborhood of Alsace Lorraine to Cunha along Kelly Ave. during her formative years. If the Coastside Inn had been converted to "transitional housing" during that time, I would've no longer felt safe in letting her walk to school, and I would've driven her instead. For if even one

homeless individual slips thru the cracks, and is a convicted rapist, then what could happen? They could easily lure a youth into their hotel room with offers of candy, drugs, alcohol, etc, and then who knows what might happen! Can any one of you live with the consequences if something like this might happen? What assurances do we have that this will never happen? None! There is no way to screen each homeless individual that would come thru the doors of the Coastside Inn- None!!! Do some of them even have ID's? SSN's? what kinds of background checks would you provide? Are background checks even legal in CA? Aren't many homeless people homeless because they don't want to register as sex offenders in California due to Megan's law??? I read that even after California relaxed the requirements to register under Megan's Law/Jessica's law, that many homeless people preferred to remain "homeless". Why might that be? So that they wouldn't have to register as a sex offender and be subject to the embarrassment?

What about convicted felons? Same questions apply as the paragraph above. Drug users? Alcoholics? Mentally ill people? All of these people would need help, that I have heard that the coastside is not equipped to handle. Do we have enough mental health, drug/alcohol, professionals to handle the influx of new cases? If not, will these people have to be bussed over the hill for these services?

What about job opportunities, or the lack there of? How are these people supposed to be able to find meaningful work on the coast, other than cleaning up the beaches as part of Abundance Grace's program? I have seen these homeless people walk thru my neighborhood picking up trash, but to be honest, I'd rather they walk up and down Kelly than thru my neighborhood on Potter Ave.

What about policing/security? We have heard your promises of increased policing (if needed). That is all just promises as far as I'm concerned. WE need 24/7/365 security of the Coastide Inn. We need to be able to see who is coming/going in these hotel rooms. To make sure there is no drug dealing, sex crimes, etc, etc. This will cost money. We need a contract in writing with how much the county will contribute toward this security cost.

How about the loss of tax revenues to our city and our local schools? I have read that the local CUSD school district would lose \$2,707/year and the city would lose \$30,250/year. Will the county commit to reimburse the city/CUSD these funds for the entirety of the homeless project? The city of HMB relies primarily on the transit occupancy tax to fund their budget. This would be a large loss for the city in perpetuity.

What is the rush to buy the hotels? Why not rent them out like they are doing in San Francisco, and then convert them back to hotels after the pandemic?

What is the rationale for using CARES act money that is designed for Covid-19 uses (short term) to solve a long term issue like homelessness?

What about the large proportion of the homeless population that never wants to live in transitional housing because of all of the rules? Has anyone done a poll as to whether the local homeless would even want to move into this housing under the stipulated rules?

I have a big fear that the homeless population on the coast would grow exponentially because of the new housing. You would give "preference to those with coastside roots". What does that mean? How would you even determine if a homeless person with no identification even has coastal roots? Take their word for it? No way to enforce this. Also, what is coast? Pacifica, HMB, EG, Montara, Pescadero, Highway 35, santa cruz? Not enforceable. If you can't fill up the hotel with locals, then you will import others from throughout the county. Then, when they leave, get evicted out of the hotel for breaking the rules, etc, they will end up homeless in HMB. Growing our homeless population.

What are the police/sheriff's views on this proposal? We haven't heard anything from them. It would be interesting to hear their views on what this will do to crime, etc on the coast.

What about funding? All we have heard is promises that the county will cover whatever costs are involved. WE want a contract with specific language that details what costs, the county will cover.

What about lawsuits that come? The city of HMB should be exempt from all lawsuits that would come from any activities that come from the hotel, and the county should be on the hooks for all lawyers, lawsuits, etc legal costs.

These are just the tip of the iceberg about what kinds of questions/concerns we have on the coast. We feel like the county is pushing this on the coastside because the homeless are not wanted on the other side of the hill, and since we are a small, seemingly insignificant population, that you can just dictate the terms to us at the last hour. Ram this down our throats without any planning, discussion, working with the community, etc. What is the hurry now? Why didn't you plan this out better 4 months ago so that we could have meaningful discussions? We'd rather wait, and vote on this proposal at the ballot box than be forced into it.

So many questions, and so little time. This stinks that someone is getting a kick back somewhere in the county. Hmbcity.org

Dear San Mateo County Board of Supervisors -

I am writing today to formally state my opposition to San Mateo County purchasing the Coastside Inn in Half Moon Bay for the purpose of sheltering the homeless. We are a small community that lacks all of the resources necessary to sustain this type of service for the homeless. Most importantly, we have no hospital, limited sheriff/police officers, no drug or alcohol interventionists, overwhelming traffic and gridlock in case of an emergency, and the area lacks sufficient entry-level job openings that those in transition to housing require to sustain themselves.

The Coastside Inn is within 2 blocks of 3 schools (Hatch Elementary School, Cunha Middle School, Pilarcitos HS) and the Coastside Boys and Girls Club. This is not an appropriate location for a homeless shelter that provides no services to families in need and that potentially will lead to additional homeless encampments in the surrounding blocks. Young children walk to school in this area and their safety is of utmost concern.

While it's been stated that local homeless will allegedly be given preference when allocating housing, I fear that additional homeless will be brought into our small community to fill the shelter and be a further drain on our limited resources. There have also been no assurances of background or criminal record checks. This housing would essentially assemble a large unknown and unpredictable population in the midst of our largest group of vulnerable youth on the coast.

I urge you to consider the overwhelming amount of community opposition to this purchase and I reiterate my vehement opposition. The Coastside already has limited resources and this proposed shelter will disproportionately pull resources from the rest of our tax paying and voting community. Vote NO on the County's purchase of the Coastside Inn.




Allow me to put our absolute opposition to your endeavor in real basic terms:


You say that drugs and alcohol won't be allowed in the shelter. But again, anything that can go wrong will. Rules will be broken.

Potential Issue Using CARES Act Funding to Purchase Homeless Hotel in Half Moon Bay

The City of Anchorage Alaska is planning to use the same funding as is San Mateo County, for the purchase of hotel properties and converting them to homeless shelters. In an abundance of caution, Anchorage City Officials asked an Inspector General to offer guidance as to whether the use of Covid-19 relief funds for that purpose was compliant with the provisions of the CARES Act.

The Inspector General was skeptical. A meeting was arranged between Anchorage officials and representatives from the Treasury Department. Attached is an email conversation between the two agencies. The email confirms the understanding of the advice offered by Treasury Department Officials. The text below is quoted from that email:

... The governments may keep the buildings after the end of the funding period. As part of demonstrating that the buildings are a necessary COVID-19 expenditure we should be providing services to homeless individuals inside the buildings by December 30, 2020...

Also attached is the FAQ provided by the County to the City of Half Moon Bay. From that FAQ:

When will these programs start?

Currently, the County is researching the acquisition processes and will be planning for the shelter program, if the hotel is purchased. The specific date of the program launch is not yet known but is projected to be in early 2021. The County will work closely with the City of Half Moon Bay throughout the planning and implementation process.

The CARES Act funding the county contemplates using is meant to cover Covid-19 related expenses. Per the guidance given the City of Anchorage Alaska by Treasury Department officials, the Hotel the County intends to buy has to be housing Homeless people by December 30th, 2020 to meet the criteria of the CARES Act.

If the Board of Supervisors votes to proceed with this plan, two questions need to answered. Will the county be able to close on the purchase, prepare the property, create a safe program and move people into the Hotel prior to December 30th, 2020? If not, has County Council sought the guidance from the Department of Treasury regarding the plan the plan?

Dan and Stephen -

Thank you for today's productive and positive conversation. We appreciated the opportunity to ask questions regarding use of Coronavirus Relief Funds (CRF) for property acquisitions and other items approved by our assembly. As we explained, COVID-19 physical distancing requirements resulted in an immediate and lasting loss of over 300 permanent shelter beds in Anchorage, and our assembly has determined that purchasing buildings to house and provide services to our homeless population is

necessary because we lack suitable alternatives. We have kept our Congressional delegation engaged on our plan to use CRF for the buildings and other plans and have committed to providing an update to them on this issue, but first wanted to ensure we have memorialized our conversation accurately.

You confirmed your office has the responsibility of making the policy determinations that Treasury's IG's office will be tasked with monitoring and implementing, and as such, your answers are greatly helpful to us as we move forward in disbursing CRF.

We particularly appreciated learning from you:

- 1) If necessary due to a lack of other suitable alternatives, governments may purchase buildings with CRF to provide housing and services to the homeless displaced by COVID-19 public health measures. As we discussed, many jurisdictions are doing this across the nation, including California, which is spending \$550 million of CRF to purchase buildings. The governments may keep the buildings after the end of the funding period. As part of demonstrating that the buildings are a necessary COVID-19 expenditure we should be providing services to homeless individuals inside the buildings by December 30, 2020. [Although this was not mentioned in the call, we assume if the spending deadline were changed by a subsequent act of Congress, we might have more time to accomplish the purchases and bring homeless individuals into the buildings.]
- 2) A simpler option for local governments like ours is to spend CRF on first responder payroll, as a presumptively eligible expense detailed in FAQ A.2. While you anticipate issuing additional FAQ language on this presumption (possibly in the next two weeks), you do not anticipate it will result in rolling back of the previously issued presumption. Spending on payroll for front-line and public-facing public safety and public health department employees is permitted; and such use of CRF may have the side effect of freeing up municipal general funds that would otherwise have paid those salaries. In other words, the legal presumption allows governments to use CRF on this payroll even if the government had previously budgeted to pay those same individuals with municipal funds. Any municipal general funds freed up by being replaced with federal dollars may then be spent under ordinary rules for spending local money without the risk the IG's office will subsequently determine that the money missed a deadline or was spent incorrectly.

We also understand you have not issued any "private rulings" to jurisdictions and you may address the issue of the purchase of buildings by issuing an updated FAQ providing guidance on when CRF may be used to purchase buildings.

Is this an accurate summary of the conversation? We want to make sure our notes from the conversation are accurate, so our summary is relayed correctly to the delegation, especially on the above two points.

Thank you again for your time and attention to this matter. It was nice to connect with you and we appreciate everything you are doing.

County of San Mateo Interest in Creating a New Homeless Shelter Program in Half Moon Bay November 2020

What is being proposed?

The County of San Mateo is considering purchasing a hotel in the City of Half Moon Bay, the Coastside Inn, in order to create a new shelter program to assist people experiencing homelessness. There are 52 rooms at the hotel.

Why?

There currently are no homeless shelters on the coastside, however there are significant needs. The 2019 One Day Homeless Count found that there were 230 unsheltered homeless individuals living on the coastside (Half Moon Bay, Pacifica, and unincorporated coastside areas). The new planned homeless shelter program will provide safe temporary living accommodations and intensive on-site support services to assist program participants with looking for permanent housing.

Who will be served?

The proposed program will serve San Mateo County community members who are experiencing homelessness, with a preference first for those who are from Half Moon Bay and the coastside area.

The program is planned to serve adults experiencing homelessness, as the largest need is for services for adults, since there are extensive existing services for families in the County. However, based on feedback from the community, the County is now exploring the feasibility of this program also being able to serve families.

Why now?

After many years of efforts from various stakeholders to create a homeless shelter program on the coast, there is now a unique opportunity where the County has time-limited federal funding available and there is a building for sale that is appropriate. Given the time-limited nature of the funding being utilized for this purchase, the acquisition must be completed by the end of December 2020, so the acquisition process is moving at an expedited pace.

Will services be provided on site?

Yes. The proposed program will provide intensive on-site services. The program will conduct a thorough assessment with each program participant, and based on that assessment, the program will create a plan to assist each participant with identifying and returning to housing, including case management, support in searching for housing, employment support, applying for financial resources, and connections to health services (including mental health and substance abuse services). The program will provide intensive on-site services to all participants and will also partner with existing community services such as Abundant Grace, Coastside Hope, ALAS, El Centro de Libertad and Coastside Clinic. Program participants will have to abide by program rules to continue their enrollment in the program.

Will the programs be staffed 24/7?

Yes, the homeless shelter program will be staffed 24 hours a day, 365 days a year. The on-site staff will monitor the site and activities at all times, ensuring the safety and security of the premises for occupants.

How long will participants stay at the shelter?

Homeless shelter programs are intended to be short term, with actual shelter stays averaging 120 days to six months. However, due to the current pandemic, stays have been longer. The intention of a shelter program is to provide temporary housing while assisting individuals in finding permanent housing. Case management services will be focused on long term housing interventions.

Is this program specifically for people who have COVID-19?

No, this program is not for those with COVID-19 and needing isolation. This program will be for people experiencing homelessness who are vulnerable (elderly and/or with existing medical conditions such as cancer, heart disease, etc.).

Will these programs eliminate homelessness in the area?

This program will be a significant step toward serving people experiencing homelessness and decreasing unsheltered homelessness, however it's likely that some unsheltered individuals may chose to continue living in their current locations. The County's homeless outreach programs will continue to provide services to unsheltered individuals, with the goal of building trust and over time, encouraging individuals to access services, shelter and housing.

When will these programs start?

Currently, the County is researching the acquisition processes and will be planning for the shelter program, if the hotel is purchased. The specific date of the program launch is not yet known but is projected to be in early 2021. The County will work closely with the City of Half Moon Bay throughout the planning and implementation process.

How are the hotel purchases being funded?

If the County proceeds to purchase the hotel, federal CARES Act funding will be utilized. The City is not being requested to help fund the purchase of the hotel. Shelter program operations will be funded by a combination of state and federal sources and additional funding sources (such as philanthropy) will be explored by the County and the non-profit agency providing the services.

How can the community be involved?

The County looks forward to working with the community on the developmental and implementation of this program. The County will be inviting City staff to participate in the process to select an experienced non-profit homeless service provider to provide the services on site.

If the homeless shelter program is implemented, the County will work closely with the selected non-profit service provider on all aspects of the programs, and the County will work with the City and community stakeholders to establish ongoing collaboration about the programs, including a Community Advisory Committee. Once the program is implemented, there may be additional opportunities for community involvement, such as volunteer opportunities.

What are the expectations of the program participants?

Those enrolled in the program will need to comply with program rules and requirements. A sample Program Rules document is provided for your reference.

These Frequently Asked Questions will be updated as new information becomes available.

Welcome and Program Rules

Welcome! Here are some things to know during your stay here. This program's goal is to provide a safe, welcoming, supportive place for people to stay while they work on finding permanent housing. You will be provided with services from your case manager to help you create a housing plan and also connect to other resources. Please read through the rules/protocols below to ensure all participants are safe during their stay here.

Rules/Protocols:

Meals: You will receive breakfast, lunch and dinner each day and have access to small snacks in between meals.

Rooms: Please maintain the cleanliness of your room. Please note that significant room damage will lead to being exited from the program.

Visitors: Visitors to your room are <u>not allowed</u> without prior approval. Having guests on site or in your room without prior approval will lead to being exited from the program.

Quiet Hours: Please keep the noise level down between the hours of 10 pm-6 am. There is also an expectation that program participants are in their rooms between the hours of 10 pm-6 am unless they have communicated with their case manager ahead of time for exceptions about their job or special circumstances.

Respecting Neighbors/Adjacent Properties/Businesses: All program participants are required to be respectful of the neighbors including adjacent properties and businesses, including no loitering. Disrespecting the neighbors' property or businesses will lead to being exited from the program.

COVID-19 Safety Protocols:

- Wear a mask that covers your nose and mouth at all times you are outside of your room. If you
 need replacement masks, please contact any staff.
- **Follow social distancing guidelines** by having at least 6 feet of space between you and another person.
- Complete the daily temperature check: Staff will conduct a temperature check daily with each program participant. If staff can't find you for the daily temperature check, a wellness check will be done.

No Smoking:

- Smoking (including marijuana) is not allowed inside any part of the building, including in rooms.
- The cigarette smoking area is located outside at _(description of location)___.
- Tampering with or disabling your room's smoke detectors will lead to being exited from the program.

Alcohol and Drugs:

- Drugs and alcohol are not permitted on site. Items related to drug or alcohol use on site, including needles, found in your room may lead to you being exited from the program due to the safety of participants and staff.
- If you would like to talk to someone about alcohol or drug use or strategies to decrease use, your case manager would be happy to discuss with you and help you connect you to various supportive service options.

Questions or concerns?

If you have any questions or concerns, please talk with your case manager or the program director, and if you have any urgent concerns or questions, please contact the staff who is on site at that time, as there are always staff on-site to assist and respond to any issues.

I oppose turning the Coastside Inn into transitional housing for the homeless for four reasons.

First, in just the short time you gave us, 2,123 people signed a petition asking you not to do this. You pushed it on us against the will of the majority of your Coastside constituents.

Second, you did it in a way that violates democratic norms, and sidesteps the safeguards designed to ensure that the project is necessary, well planned, and a good use of our tax dollars—studies of impacts and alternatives, meaningful public input, and so on. You have disrupted our community and created division, distrust, anger and resentment—against both the County and City, neither of is acting in our interests. Councilmember Penrose was right when she said that because she supported your project she won't survive the next election. In two years you will deal with a City Council that is hostile to both the County and the homeless shelter.

Third, you haven't thought this through. You say you will appoint a citizen's advisory board—*after* you spend \$8 million. You say you will negotiate with the City to ameliorate the negative impacts on *their* tax revenues, *after* you commit that money--but you won't ameliorate the much greater negative impacts on the property values and business sales that generate that revenue. Comments on Agenda Item 11 - Proposed Acquisition of Coastside Inn

The proposed transitional housing project in Half Moon Bay has triggered huge community opposition due to the rushed nature of this transaction and the lingering unanswered questions. Unlike other County municipalities, our Coastside community is relatively isolated with limited access via two often congested roads and has limited health facilities, public safety infrastructure, addiction treatment and employment resources. Even more concerning is that this shelter is to be situated close to two schools and several residential neighborhoods.

These unique circumstances mean that this project – if not managed with meaningful community input - has the potential to have a huge negative impact on our community. This makes it critical that a Community Advisory Council be established to have input on every phase of this project ranging from resident screening, operator selection, program design and facility management. This council could be a vital channel of communication between the community and City and County governments about emerging negative community impacts and needs and could play a valuable role in educating the public about ongoing facility operations.

There is a lot at stake for HMB's future. If this facility winds up adding to the homeless population, increasing crime or undermining the town's appeal to visitors it could create more problems than it solves and severely hamper the recovery of our Coastside community from the pandemic.

I am requesting that the County to be transparent and responsive to the Community's concerns and needs arising from this project — as expressed by the City of HMB and any Community Advisory Council. This is the only way to ensure that the unique and special character of this community is preserved and we can continue to be a treasured recreational resource for the Bay area.
