RESOLUTION AUTHORIZING THE ESTABLISHMENT OF "NO PARKING" ZONES ON VERMONT AVENUE AND NORTH LAKE STREET, UNINCORPORATED MOSS BEACH

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, California Vehicle Code Section 22507 et al. and Section 7.30.010 of the San Mateo County Ordinance Code allow the Board of Supervisors to prohibit or restrict the stopping, parking or standing of vehicles by resolution or ordinance; and

WHEREAS, in reviewing parking restrictions along North Lake Street and Vermont Avenue, the Department was unable to locate a resolution/ordinance establishing the posted parking restrictions on North Lake Street and/or Vermont Street, in the vicinity of Virginia Avenue; and

WHEREAS, "No Parking" zones are posted along both sides of North Lake Street between California Avenue and Vermont Avenue and on Vermont Avenue at North Lake Street; and

**WHEREAS,** the Director of Public Works has recommended that a "No Parking" zone resolution be approved to recognize these zones as noted herein; and

WHEREAS, the Director of Public Works has recommended that the "No Parking" zones currently posted on North Lake Street and Vermont Avenue be included in this Resolution; and

**WHEREAS**, this Board has reviewed and concurs with the recommendation of the Director of Public Works.

## **IT IS FURTHER DETERMINED AND ORDERED** that:

- 1. A "No Parking Zone" be established at the following locations:
  - North Lake Street (Road 1032), unincorporated Moss Beach, beginning twelve feet (12.0') east of the centerline of California Avenue then traveling in an easterly direction on south side of the road for five hundred and forty-one feet (541.0'), more, or less.
- 2. A "No Parking Zone" be established at the following locations:
  - North Lake Street (Road 1032), unincorporated Moss Beach, beginning at twelve feet (12.0') east of the centerline of California Ave then traveling in an easterly direction on north side of the road for two hundred sixty-six feet (266.0'), more, or less.
- 3. A "No Parking Zone" be established at the following locations:
  - North Lake Street (Road 1032), unincorporated Moss Beach, beginning twelve feet (12.0') east of the centerline of Virginia Avenue then traveling in an easterly direction on north side of the road for two hundred fifty-three feet (253.0'), more, or less.
- 4. A "No Parking Zone" be established at the following locations:
  - Vermont Avenue (Road 1039-A), unincorporated Moss Beach, beginning twelve feet (12.0') south of the centerline of North Lake Street then traveling

in a northerly direction on east side of the road for one hundred and two feet (102.0'), more, or less.

5. A "No Parking Zone" be established at the following locations:

Vermont Avenue (Road 1039-A), unincorporated Moss Beach, beginning twelve feet (12.0') north of the centerline of North Lake Street then traveling in a northerly direction on west side of the road for fifteen feet, (15.0') more, or less.

The Department of Public Works is authorized and directed to post any additional signs and pavement markings.
