RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH LIFEMOVES FOR COMMUNITY HEALTH OUTREACH SERVICES, EXTENDING THE TERM THROUGH JUNE 30, 2022, INCREASING THE FISCAL OBLIGATION BY \$103,000 TO AN AMOUNT NOT TO EXCEED \$412,770, AND TO CORRECTLY LABEL THE TITLE TO FIRST AMENDMENT WHICH WAS INADVERTENTLY LABELLED THE SECOND AMENDMENT

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS San Mateo County Health (SMCH) implemented the Whole Person Care (WPC) pilot under the Medi-Cal 2020 1115 waiver: and

WHEREAS, SMCH has prioritized three target populations for services under the pilot, including those who are high utilizers of emergency services and who may have mental health challenges, substance use disorder and/or experience homelessness, and the WPC pilot seeks to outreach locate and engage such populations: and

WHEREAS, in FY 2017-20, the Human Services Agency (HSA), Center on Homelessness, contracted directly with a provider for these services on behalf of the Whole Person Care pilot following an appropriate Request for Proposals (RFP) process, and SMCH and the HSA agreed that the WPC pilot should contract directly with a provider for community health outreach services for FY 2020-21 and going forward; and

WHEREAS a thorough and transparent RFP process was conducted by the HSA and in 2020 the HSA received a waiver to extend their homeless outreach contract with LifeMoves to a five-year term extending through FY 2021-22, and on June 30, 2020, this Board approved Resolution 077550, approving an agreement between SMCH and LifeMoves for community health outreach services for the period July 1, 2020 through June 30, 2021; and

WHEREAS, on December 29, 2020 the Centers for Medicare and Medicaid services approved the Department of Health Care Services (DHCS) proposal for an extension of the 1115 Waiver through December 2021, and in order to ensure continuity of the community health outreach work program through the end of the WPC pilot, on June 29, 2021, this Board approved Resolution 078257, an agreement between SMCH and LifeMoves for community health outreach services for the period July 1, 2021 through December 31, 2021; and

WHEREAS, the DHCS has received approval to implement a multi-year initiative entitled California Advancing and Innovating Medi-Cal (CalAim) effective January 1, 2022, which is designed to improve the quality of life and health outcomes of California residents by implementing broad delivery system, program and payment reform across the Medi-Cal program; and

WHEREAS, under the CalAim initiative, a new Medi-caid benefit entitled Enhanced Care Management (ECM) will be administered by Managed Care Plans and

it is anticipated that the Bridges to Wellness program, within Public Health, Policy and Planning, will become a provider of ECM under contract with the Health Plan of San Mateo (HPSM) within the first six months of 2022; and

WHEREAS, the Bridges to Wellness program contracts for services through LifeMoves to meet some of the outreach needs of the unhoused that will eventually be provided by the HPSM, and it is anticipated that the HPSM will contract for similar services sometime after June 30, 2022; and

WHEREAS, extending the agreement with LifeMoves for community health outreach services will ensure continuity of care for clients through June 30, 2022; and

WHEREAS, the parties now wish to execute an amendment the agreement to extend the term through June 30, 2022, increase the fiscal obligation by \$103,000 from \$309,770 to \$412,770 and correctly label the First Amendment; and

WHEREAS, this Board has been presented with the amendment and has approved it as to both form and content and desires to enter the amendment.

NOW THEREFORE, IT IS HEREBY DETERMINED AND RESOLVED that the President of the Board of Supervisors be and is hereby authorized and directed to execute said amendment for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto; and

BE IT FURTHER RESOLVED that the Chief of SMCH or designee is authorized to execute contracts amendments which modify the county's maximum fiscal obligation by no more than \$25,000 (in aggregate) and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
