FIRST AMENDMENT TO THE AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND PERFECTSERVE, INC.

THIS FIRST AMENDMENT TO THE AGREEMENT, entered into this day of
2022, by and between the COUNTY OF SAN MATEO, hereinafter called "County", and
PERFECTSERVE, INC., hereinafter called "Contractor"

WITNESSETH:

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement, to provide comprehensive and secure, communications-driven workflow solutions via integrated, cloud-based mobile application, web and telephony software that is accessible to users via the internet and the public switched telephone network ("**PSTN**") and sold as software as a service ("**SaaS**") on February 13, 2021, referred to herein as "Agreement"; and

WHEREAS, the parties wish to amend the Agreement to extend the term from February 13, 2021 through February 12, 2022 to February 12, 2024 and increase the not to exceed amount by \$240,000 from \$158,000 to \$398,000 to cover the payment for the extended term.

NOW, THEREFORE, IT IS HEREBY AGEED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 1, Exhibits and Attachments, of the Agreement is amended to read as follows:

2. Section 3, Payments, of the Agreement is deleted in its entirety and replaced to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions, and specifications set forth in this Agreement and in Exhibit A, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B. In no event shall County's total fiscal obligation under this Agreement exceed Three Hundred Ninety-Eight Thousand Dollars (\$398,000). In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination or expiration. Contractor is not entitled to payment for work not performed as required by this agreement. All invoices must be approved by the Health Chief Information Officer or designee and paid within thirty (30) days of receipt of the invoice. Invoices must be sent to:

- 3. Section 4, Term, of the Agreement is deleted in its entirety and replaced to read as follows:
 - Subject to compliance with all terms and conditions, the term of this Agreement shall be from February 13, 2021 through February 12, 2024.
- 4. Exhibit B is hereby replaced with Exhibit B1 attached hereto.
- 5. All other terms and conditions of the Agreement dated February 13, 2021 between County and Contractor, except as expressly amended herein, shall remain in full force and effect.
