**AMENDMENT TO AGREEMENT
BETWEEN THE COUNTY OF SAN MATEO AND
CORNERSTONE ONDEMAND, INC.**

THIS AMENDMENT TO THE AGREEMENT, entered into this 8th day of February, 2022, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Cornerstone OnDemand, Inc., hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, on October 22, 2019, the Board of Supervisors approved Resolution No. 077007 authorizing an agreement with Contractor, and which authorized the Human Resources Director or the Director's designee to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000; and

WHEREAS, the parties entered into an Agreement for learning management system services on October 22, 2019, for the term of October 31, 2019 through October 30, 2022, in an amount not to exceed \$574,645; and

WHEREAS, the Human Resources Director executed a contract amendment to increase the contract amount by \$25,000 for a new agreement amount not to exceed \$599,645, effective October 31, 2021; and

WHEREAS, as part of this Agreement, optional fourth- and fifth-year extensions were incorporated, to be exercised at the County's sole discretion, with approved amounts for an optional fourth year not to exceed an additional \$150,124.85, and an optional fifth year not to exceed an additional \$154,628.59; and

WHEREAS, the County now wishes to exercise these fourth and fifth-year options, extending the Agreement term through October 30, 2024; and

WHEREAS, the parties wish to increase the amount of the Agreement to incorporate an additional \$227,572.31 for the costs of expanded e-learning and additional user licenses; and

WHEREAS, the parties wish to amend the Agreement to incorporate the already approved fourth and fifth-year extension costs as well as the costs of expanded e-learning and additional user licenses for a total not-to-exceed amount of \$1,131,970.75.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. The fourth sentence from Section 3 of the agreement is amended to read as follows:

In no event shall County's total fiscal obligation under this Agreement exceed One Million One Hundred Thirty-One Thousand and Nine Hundred Seventy Dollars and 75 Cents (\$1,131,970.75) over the course of this Agreement.

3. Section 4 is amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from October 31, 2019 through October 30, 2024.

4. **All other terms and conditions of the agreement dated October 22, 2019, between the County and Contractor shall remain in full force and effect.**
