RESOLUTION: A) CONSOLIDATING THE STATEWIDE DIRECT PRIMARY ELECTION, TO BE HELD ON TUESDAY, JUNE 7, 2022, WITH ELECTIONS CALLED BY THE BELMONT-REDWOOD SHORES SCHOOL DISTRICT, BRISBANE SCHOOL DISTRICT, HILLSBOROUGH CITY SCHOOL DISTRICT, JEFFERSON ELEMENTARY SCHOOL DISTRICT, MILLBRAE ELEMENTARY SCHOOL DISTRICT, AND RAVENSWOOD CITY SCHOOL DISTRICT; AND B) AUTHORIZING THE COUNTY'S CHIEF ELECTIONS OFFICER TO RENDER SPECIFIED ELECTION SERVICES IN CONJUNCTION THEREWITH

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, pursuant to Sections 10400 through 10418 of the Elections Code, the County Board of Supervisors may, upon request, order the consolidation of elections that are called to be held on the same day and in or within the same territory upon the order of the governing body or bodies calling the elections and the consolidated election shall be held in all respects as if it were one election, with the returns being canvassed by the County's Chief Elections Officer; and

WHEREAS, absent other arrangements or applicable law, the costs of any school district election shall be borne by the school district holding the election pursuant to Section 5421 of the Education Code, and any city or district shall reimburse the County in full for the services performed by the County's Chief Elections Officer in accordance with Division 10 of the Elections Code; and

WHEREAS, pursuant to state law, the Board of Trustees of the Belmont-Redwood Shores School District adopted Resolution 2021-2022 #15 giving notice of holding an election on June 7, 2022, for the purpose of submitting a parcel tax measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, pursuant to state law, the Board of Trustees of the Brisbane School District adopted Resolution 2021-2022, No. X, giving notice of holding an election on June 7, 2022, for the purpose of submitting a parcel tax measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, pursuant to state law, the Board of Trustees of the Hillsborough City School District adopted Resolution No. 2022-01, giving notice of holding an election on June 7, 2022, for the purpose of submitting a bond measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, pursuant to state law, the Board of Trustees of the Jefferson Elementary School District adopted Resolution No. 22-02-09A, giving notice of holding an election on June 7, 2022, for the purpose of submitting a bond measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, pursuant to state law, the Board of Trustees of the Millbrae Elementary School District adopted Resolution No. 21-22-11, giving notice of holding an election on June 7, 2022, for the purpose of submitting a bond measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, pursuant to state law, the Board of Trustees of the Ravenswood City School District adopted Resolution No. 2021/22-17, giving notice of holding an election on June 7, 2022, for the purpose of submitting a bond measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, each of the aforementioned districts has requested their respective elections to be consolidated with June 7, 2022, Statewide Direct Primary Election; and

WHEREAS, the County's Chief Elections Officer is agreeable to providing specified election services as duly requested and enumerated above in conjunction with the Statewide Direct Primary Election to be held on Tuesday, June 7, 2022; and

WHEREAS, in consideration of the services and supplies to be provided by the County's Chief Elections Officer in conducting said election, the Belmont-Redwood Shores School District, Brisbane School District, Hillsborough City School District, Jefferson Elementary School District, Millbrae Elementary School District, and the Ravenswood City School District will, as required by law, enter into separate agreements with the County's Chief Elections Officer to outline the services to be rendered and to reimburse the County for the costs of said services and supplies.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that (A) the June 7, 2022 Statewide Direct Primary Election is hereby consolidated with the above-named local elections duly called by their respective governing bodies; and (B) the County's Chief Elections Officer is authorized to render specified election services in conjunction therewith.
