

# ANNUAL ACTION PLAN

- County is an entitlement jurisdiction that receives direct CDBG, HOME, and ESG allocations from HUD
- 5-year Consolidated Plan (ConPlan) approved in 2018
  - Consists of Annual Action Plan
  - FY2022 Annual Action Plan is Year 5 of the 5-year ConPlan
- National Objectives:
  - Provision of decent affordable housing
  - Provision of a suitable living environment
  - Expansion of economic opportunities

# URBAN COUNTY: CDBG, HOME, AND ESG



- **Urban County** = 16 non-entitlement cities and towns + County
  - Excludes Cities of Daly City, South San Francisco, Redwood City, and San Mateo
- DOH administers CDBG, HOME and ESG annually on behalf of Urban County
- 3-year Cooperative Agreements with each jurisdiction with automatic renewal provisions


