**RESOLUTION AUTHORIZING THE PRESIDENT OF THE BOARD OF SUPERVISORS TO EXECUTE A SECOND AMENDMENT TO THE AGREEMENT WITH SUCCESS CENTERS THROUGH THE YOUTHFUL OFFENDER BLOCK GRANT (YOBG) TO CONTINUE TO PROVIDE ACADEMIC STUDY HALL, JOB READINESS TRAINING, AND A VISUAL ARTS PROGRAM TO YOUTH AT THE SAN MATEO COUNTY PROBATION DEPARTMENT'S YOUTH SERVICES CENTER-JUVENILE HALL (YSC-JH) BY EXTENDING THE TERM END DATE TO JUNE 30, 2023 AND INCREASING THE AMOUNT BY \$95,142.56 TO AN AMOUNT NOT TO EXCEED \$285,427.68**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, in January 2020, the Probation Department completed a Request for Proposals (RFP) process to establish contracts for youth activities and mental health services funded through the Youthful Offender Block Grant (YOBG); and

**WHEREAS**, Success Centers was among five community-based organizations selected through the RFP process to provide YOBG-funded services to youth at the Youth Services Center-Juvenile Hall; and

**WHEREAS**, on July 10, 2020, the San Mateo County Probation Department and Success Centers entered into an agreement for the purpose of providing academic study hall, job readiness training, and visual arts programs for the term of July 1, 2020, through June 30, 2021, in an amount not to exceed \$95,142.56; and

**WHEREAS**, on June 16, 2021, the agreement was amended to extend the term by one year through June 30, 2022, and increase the amount by \$95,142.56 to an amount not to exceed \$190,285.12; and

**WHEREAS**, during FY 2020-21, Success Centers' job readiness training program served 29 youths with 88% self-reporting enhanced job readiness and life skills as a result, exceeding the contract's performance measure target of 80%; and

**WHEREAS**, during FY 2021-22, Success Centers' visual arts program served 11 youths, all of whom self-reported learning new skills and feeling confident enough to use these skills in real-life situations; and

**WHEREAS**, the Probation Department and Success Centers wish to extend the term of the agreement by an additional year through June 30, 2023, and increase the amount by \$95,142.56 to an amount not to exceed \$285,427.68; and

**WHEREAS**, the Board has been presented with this agreement and has approved it as to both form and content and desires to enter into this agreement.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the President of the Board of Supervisors be, and is hereby, authorized and directed to execute said Revenue Agreement for and on behalf of the County of San Mateo and the Clerk of the Board shall attest the President's signature thereto.

**BE IT FURTHER RESOLVED** that the:

Chief Probation Officer or designee is hereby authorized to execute contract amendments that modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or service so long as the modified term or services is/are within the current or revised fiscal provisions.
