THIRD AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND SUTTER BAY MEDICAL FOUNDATION, A CALIFORNIA NONPROFIT PUBLIC BENEFIT CORPORATION DBA PALO ALTO MEDICAL FOUNDATION FOR HEALTH CARE, RESEARCH AND EDUCATION FOR VASCULAR SURGERY SERVICES

THIS AMENDMENT TO THE AGREEMENT, entered into this 28th day of June, 2022, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Sutter Bay Medical Foundation, a California nonprofit public benefit corporation dba Palo Alto Medical Foundation for Health Care, Research and Education, hereinafter called "Contractor";

WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for vascular surgery services on May 5, 2020 for the term of April 1, 2020 through March 31, 2022 for an amount not to exceed \$909,245;

WHEREAS, the parties amended the Agreement to extend the term by two months to allow for additional negotiation time and to add \$75,770 to the Agreement (First Amendment) increasing the do not exceed amount to \$985,015; and

WHEREAS, the parties amended the Agreement to extend the term by one month to allow for additional negotiation time and to add \$37,885 to the Agreement (Second Amendment) increasing the do not exceed amount to \$1,022,900; and

WHEREAS, the parties wish to amend the Agreement to extend the term by two months to allow for additional negotiation time and to add \$75,770 to the agreement thereby increasing the do not exceed amount from \$1,022,900 to \$1,098,670.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

- 1. Section 1.5.1 of the agreement is amended to read as follows: In full consideration of Contractor's performance of the services described in Exhibit A, the amount that County shall pay for services rendered under this Agreement shall be as specified in Exhibit B, not to exceed ONE MILLION NINETY-EIGHT THOUSAND SIX HUNDRED AND SEVENTY DOLLARS (\$1,098,670).
- Section 3.1 of the agreement is amended to read as follows:
 Subject to compliance with all terms and conditions, the term of this Agreement shall be from April 1, 2020 through August 31, 2022.

3. Exhibit B, Section VII of the agreement is amended to read as follows:

Total payment for services performed under this Agreement will not exceed ONE MILLION NINETY-EIGHT THOUSAND SIX HUNDRED AND SEVENTY DOLLARS (\$1,098,670).

4. Exhibit B, Section VIII of the agreement is amended to read as follows:

The term of this Agreement is April 1, 2020 through August 31, 2022.

5. All other terms and conditions of the agreement, as previously amended, between the County and Contractor shall remain in full force and effect.
