**RESOLUTION AUTHORIZING THE CONTROLLER TO CONTINUE PAYMENTS ON  
CERTAIN COUNTY HEALTH CONTRACTS FROM JULY 1, 2022 THROUGH  
SEPTEMBER 30, 2022**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, each of the agreements with the contractors listed in Attachment A, incorporated by reference herein, expires on or before June 30, 2022, and negotiation of new agreements for the services covered by these agreements is pending; and

**WHEREAS**, absent action by this Board, the Controller will lack authority to make payments to the contractors providing services under these agreements between their respective expiration dates and the time at which the Board approves new agreements for these services; and

**WHEREAS**, this Board wishes to authorize the Controller to continue making payments to the contractors providing services under the contracts listed in Attachment A, through September 30, 2022 pending execution of new agreements, in amounts not to exceed those set forth for each contractor in Attachment A and at the currently existing rates as set forth in the most recent agreements between the contractors and the County.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that this Board authorizes the Controller to continue making payments to contractors through September 30, 2022, on the agreements listed in Attachment A for and on behalf of the County, in amounts not to exceed those set forth in Attachment A, subject to the contractors' continued compliance with all terms and conditions of these agreements, with the exception of the maximum payment term provision, and said payments are to be in the amounts authorized by the Chief of San Mateo County Health or designee at the currently existing rates as set forth in the most recent agreements with the County.
