**RESOLUTION AUTHORIZING: A)THE DIRECTOR OF THE PROJECT DEVELOPMENT UNIT, OR DESIGNEE, TO EXECUTE NEW PURCHASE ORDERS WITH ONE WORKPLACE TO PROCURE, FURNISH, AND INSTALL FURNITURE, AND PROVIDE MOVING SERVICES FOR THE SAN MATEO COUNTY NAVIGATION CENTER PROJECT IN AN AMOUNT NOT TO EXCEED \$700,000; AND B) THE DIRECTOR OF THE PROJECT DEVELOPMENT UNIT, OR DESIGNEE, TO EXECUTE ADDITIONAL PURCHASE ORDERS AND AMENDMENTS TO PURCHASE ORDERS IN AN AMOUNT NOT TO EXCEED \$100,000 FOR A TOTAL MAXIMUM FISCAL OBLIGATION OF \$800,000**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, San Mateo County continues to face an unprecedented and growing shelter crisis, with homelessness experienced disproportionately by members of minority groups; and

**WHEREAS**, as part of the response to the growing shelter crisis, the County of San Mateo, on January 25, 2022, authorized the San Mateo County Navigation Center Project at a target budget of \$57,000,000; and

**WHEREAS**, the Navigation Center will provide 240 safe temporary living units and intensive on-site support services to individuals and couples experiencing homelessness; and

**WHEREAS**, the Navigation Center requires various furnishings including sleeping unit furniture, community room tables and chairs, conference room tables and chairs, dining hall furniture, office furniture, and outdoor furniture; and

**WHEREAS**, One Workplace was selected through a competitive Request for Proposals (RFP) issued by the County of San Mateo and will provide furniture and services for the Navigation Center Project pursuant to pricing established through the RFP and/or through applicable General Service Administration agreements; and

**WHEREAS**, the selected items of furniture to be acquired through One Workplace are industry-proven products that should provide years of use to the Navigation Center.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the Director of the Project Development Unit, or designee, is authorized to execute new purchase orders and other forms of agreement, and amendments thereto, with One Workplace to procure, furnish, and install furniture, and provide moving services, for the San Mateo County Navigation Center project in the amount of \$700,000.

**IT IS FURTHER DETERMINED AND ORDERED** that the Director of the Project Development Unit, or designee, is authorized to issue and execute additional purchase orders or amendments to purchase orders in the amount of \$100,000, for a total not to exceed fiscal obligation of \$800,000 provided that the form of such purchase orders and/or other forms of agreement are reviewed and approved by the County Attorney's Office.
