Existing Cannabis Ordinance

- Allows for cannabis cultivation....
 - in existing greenhouses...
 - on ag zoned or traditionally farmed land
 - with restrictions on location
 - with odor and ventilation requirements
 - with appropriate security measures
 - with runoff, storm water and wastewater plans



Each license is subject to CEQA



Existing Cannabis Licenses

Number of Properties with Cannabis Licenses:	2
Total Number of Active Licenses:	5
New Applications:	3
Approved Licenses Seeking Expansion:	1
Total Permitted Cannabis Square Footage:	188,071 sq ft
Nursery sq ft (Not Flowering) of Total:	103,843 sq ft



Proposed Amendments

- Elimination of 66,000 sf per operator per parcel limit
- Elimination of requirement to replace displaced ag
- Water use and documentation changes
- Transfer of ownership and modification procedures
- Cannabis licensees allowed to distribute between
 State and local cannabis licensees.
- Licenses extended from 1 year to 5 years
- Streamlined application requirements





ENVIRONMENTAL REVIEW

Staff prepared an Initial Study and Negative Declaration pursuant to the California Environmental Quality Act (CEQA), with a public review period of March 16, 2022 to April 4, 2022.

After the comment period minor changes were made for clarity and to correct minor technical errors, no recirculation was required pursuant to CEQA Guidelines.

- 2. Introduce an ordinance amending Chapter 5.148 of the County Ordinance Code regarding commercial cannabis cultivation in the unincorporated area of San Mateo County and waive the reading of the ordinance in its entirety.
