**RESOLUTION AUTHORIZING AN AMENDMENT TO MASTER SALARY
RESOLUTION 079043 TO DELETE ONE POSITION, ADD THREE POSITIONS,
CONVERT ONE POSITION TO CLASSIFIED VIA MEASURE D, AND AMEND THE
SPECIAL COMPENSATION SECTION OF THE MASTER SALARY RESOLUTION;
AND ACCEPT THE UPDATED REPORT OF BIWEEKLY SALARIES BY
CLASSIFICATION**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

WHEREAS, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

WHEREAS, San Mateo County Ordinance No. 07303 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

NOW THEREFORE, IT IS HEREBY ORDERED that the Board of Supervisors authorizes an amendment to Master Salary Resolution 079043 as follows:

SECTION 1: Section 5 of the Resolution is amended as indicated:

ALL ORGANIZATIONS

1. Professional staff and supervisors who are assigned child or adult protective services responsibilities by their Director or the Director's designee shall receive a 5% differential pay in addition to all other compensation.

SECTION 2: Part 14 of the Resolution is amended as indicated:

ORGANIZATION 32000 PROBATION DEPARTMENT

1. Item E458S, Revenue Collector Series is increased by 1 position for a new total of 1 position.
2. Item E455, Revenue Collection Supervisor-Exempt is increased by 1 position for a new total of 1 position.

ORGANIZATION 57000 AGING AND ADULT SERVICES

1. Item E350, Fiscal Office Specialist is decreased by 1 position for a new total of 10 positions.
2. Item E030S, Accountant Series is increased by 1 position for a new total of 5 positions.

ORGANIZATION 61000 BEHAVIORAL HEALTH AND RECOVER SERVICES

1. Item B013S, Case Management/Assessment Specialist-Unclassified Series is decreased by 1 position for a new total of 1 position.
2. Item G240S, Case Management/Assessment Specialist Series is increased by 1 position for a new total of 17 positions.

SECTION 3: Effective Date

1. All changes are effective on the first pay period following adoption.
