RESOLUTION: A) CONSOLIDATING THE STATEWIDE GENERAL ELECTION, TO BE HELD ON TUESDAY, NOVEMBER 8, 2022, WITH ELECTIONS CALLED BY LOCAL GOVERNING BODIES THAT HAVE REQUESTED THEIR RESPECTIVE ELECTIONS BE CONSOLIDATED WITH THE STATEWIDE GENERAL ELECTION; AND B) AUTHORIZING THE COUNTY'S CHIEF ELECTIONS OFFICER TO PROVIDE SPECIFIED ELECTION SERVICES AND SUPPLIES IN CONJUNCTION THEREWITH

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Election Code Sections 10400 through 10418 authorize the Board to order the consolidation of elections that are called to be held on the same day in or within the same territory upon the order of the governing body or bodies calling the elections and, if ordered, the consolidated election shall be held in all respects as if it were one election, with the returns being canvassed by the County's Chief Elections Officer; and

WHEREAS, absent other arrangements or applicable law, the costs of any school district election shall be borne by the school district holding the election pursuant Education Code Section 5421, and any city or district shall reimburse the County in full for the services performed by the County's Chief Elections Officer in accordance with Division 10 of the Elections Code; and

WHEREAS, the following school districts are required by law to hold regularly-scheduled governing board elections, have notified the County's Chief Elections Officer of the number of seats to be elected and the relevant policies for breaking a tie vote, and are requesting an election as more candidates have filed to run for office in the named jurisdictions than there are seats available: San Mateo County Board of Education; Bayshore Elementary School District; Belmont-Redwood Shores School District; Brisbane School District, Burlingame Elementary School District; Cabrillo Unified School District; Hillsborough City High School District; Jefferson Elementary School District; Jefferson Union High School District; La Honda-Pescadero Unified School District; Las Lomas Elementary School District; Menlo Park City School District; Millbrae Elementary School District; Pacifica School District; Portola Valley Elementary School District; Ravenswood City School District; Redwood City School District; San Bruno Park Elementary School District; San Carlos School District; San Mateo County Community College District; San Mateo-Foster City School District; San Mateo Union High School District; Sequoia Union High School District; South San Francisco Unified School District; and Woodside Elementary School District; and

WHEREAS, the following districts and/or community councils are required by law to hold regularly-scheduled governing board elections, have notified the County's Chief Elections Officer of the number of seats to be elected and the relevant policies for breaking a tie vote, and are requesting an election as more candidates have filed to run for office in the named jurisdictions than there are seats available: the Bayshore Sanitary District; Broadmoor Police Protection District; Coastside County Water District; Coastside Fire Protection District; Colma Fire Protection District; East Palo Alto

Sanitary District; Granada Community Services District; Highlands Recreation District; Ladera Recreation District, Menlo Park Fire Protection District; Mid-Peninsula Regional Open Space District; Mid-Peninsula Water District; Montara Water and Sanitary District; North Coast County Water District; Peninsula Health Care District; San Mateo County Harbor District; Sequoia Health Care District; West Bay Sanitary District; Westborough Water District; Woodside Fire Protection District; and Midcoast Community Council; and

WHEREAS, the governing board of the Bayshore Elementary School District adopted Resolution No. 21-22 giving notice of an election to be held on November 8, 2022 for the purpose of submitting a parcel tax measure to District voters and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the governing board of the La Honda-Pescadero Unified School District adopted Resolution No. 22-23-02 giving notice of an election to be held on November 8, 2022 for the purpose of submitting a bond measure to District voters and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the governing board of the Redwood City School District adopted Resolution No. 2 giving notice of an election to be held on November 8, 2022 for the purpose of submitting a bond measure to District voters and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the governing board of the Sequoia Union High School District adopted Resolution No. 1736A giving notice of an election to be held on November 8,

2022 for the purpose of submitting a bond measure to District voters and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the governing board of the South San Francisco Unified School District adopted Resolution No. 22-47 giving notice of an election to be held on November 8, 2022 for the purpose of submitting a bond measure to District voters and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of the Town of Atherton has adopted Resolution No. 22-15 giving notice of an election to be held on November 8, 2022 for the purpose of electing three city council members for a term of four years each and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of the City of Belmont has adopted Resolution Nos. 2022-067 and 2022-079, giving notice of an election to be held on November 8, 2022 for the purpose of electing two city council members for a term of four years each and one Mayor-at-large, submitting to Belmont voters a measure increasing its hotel room tax, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of the City of Brisbane has adopted Resolution Nos. 2022-048, 2022-057, and 2022-058 giving notice of an election to be held on November 8, 2022 for the purpose of electing two city council members for a term of four years

each, submitting to Brisbane voters a hotel business license tax measure and a transactions and use (sales) tax measure, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of the City of Burlingame has adopted Resolution Nos. 037-2022 and 089-2022 giving notice of an election to be held on November 8, 2022 for the purpose of electing three city council members for a term of four years each, submitting to Burlingame voters a measure updating its business licensing, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of the Town of Colma has adopted Resolution No. 2022-19 giving notice of an election to be held on November 8, 2022 for the purpose of electing two city council members for a term of four years each and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of the City of Daly City has adopted Resolution No. 22-90 giving notice of an election to be held on November 8, 2022 for the purpose of electing three city council members for a term of four years each and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of the City of East Palo Alto has adopted Resolution Nos. 54-2022 and 57-2022 giving notice of an election to be held on November 8, 2022 for the purpose of electing two city council members for a term of four years each,

submitting to East Palo Alto voters a measure increasing its business tax, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of Foster City has adopted Resolution No. 2022-063 giving notice of an election to be held on November 8, 2022 for the purpose of electing two city council members for a term of four years each and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of the City of Half Moon Bay has adopted Resolution No. C-2022-35 giving notice of an election to be held on November 8, 2022 for the purpose of electing three city council members for a term of four years each and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of the Town of Hillsborough has adopted Resolution No. 22-43 giving notice of an election to be held on November 8, 2022 for the purpose of electing two city council members for a term of four years each and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of the City of Menlo Park has adopted Resolution Nos. 6744 and 6757 giving notice of an election to be held on November 8, 2022 for the purpose of electing three city council members for a term of four years each, submitting to Menlo Park voters a citizen-sponsored initiative measure to amend the Land Use

Element of the General Plan, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of the City of Millbrae has adopted Resolution Nos. 22-47 and 22-61 giving notice of an election to be held on November 8, 2022 for the purpose of electing two city council members for a term of four years each, submitting to Millbrae voters measure increasing its transient occupancy tax, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of the City of Pacifica has adopted Resolution Nos. 30-2022, 31-2022, and 35-2022 giving notice of an election to be held on November 8, 2022 for the purpose of electing three city council members for a term of four years each, submitting to Pacifica voters an advisory measure regarding the sale and use of state-approved fireworks and a transactions and use (sales) tax measure, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the Town Council of the Town of Portola Valley has adopted Resolution No. 2900-2022 giving notice of an election to be held on November 8, 2022 for the purpose of electing three city council members for a term of four years each and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of Redwood City has adopted Resolution Nos. 16056 and 16070 giving notice of an election to be held on November 8, 2022 for the

purpose of electing three city council members for a term of four years each, submitting to Redwood City voters two charter amendment measures, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of the City of San Bruno has adopted Resolution Nos. 2022-55 and 2022-80 giving notice of an election to be held on November 8, 2022 for the purpose of electing two city council members for a term of four years each and electing one mayor to a full two year term, submitting to San Bruno voters a measure amending term limits, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of the City of San Carlos has adopted Resolution No. 2022-062 giving notice of an election to be held on November 8, 2022 for the purpose of electing three city council members for a term of four years each and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of the City of San Mateo has adopted Resolution Nos. 70(2022) and 76(2022) giving notice of an election to be held on November 8, 2022 for the purpose of electing three city council members for a term of four years each, submitting to San Mateo voters a measure increasing the transfer tax on certain real property sales, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the City Council of the City of South San Francisco has adopted Resolution Nos. 94-2022, 123-2022, and 139-2022 giving notice of an election to be

held on November 8, 2022 for the purpose of electing three city council members, a city clerk, and a city treasurer, for a term of four years each, submitting to South San Francisco voters an affordable housing authorization measure and parcel tax initiative, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, the Town Council of the Town of Woodside has adopted Resolution Nos. 2022-7505 and 2022-7506 giving notice of an election to be held on November 8, 2022 for the purpose of electing one city council member for a term of two years, electing two city council members for a term of four years, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

WHEREAS, each of the aforementioned local governing bodies has requested that their respective elections, as described in the above findings, be consolidated with the November 8, 2022 Statewide General Election ("November 2022 General Election"); and

WHEREAS, the County's Chief Elections Officer is agreeable to providing specified election services and supplies requested and enumerated in the above findings in conjunction with the November 2022 General Election; and

WHEREAS, in consideration of the services and supplies to be provided by the County's Chief Elections Officer in conducting the elections described in the above findings, each local governing body requesting such services and supplies will, as required by law, enter into separate agreements with the County's Chief Elections

Officer to outline the services to be rendered and to reimburse the County for the costs of said services and supplies.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that (A) the November 2022 General Election is hereby consolidated with the local elections described in this Resolution duly called by their respective governing bodies; and (B) the County's Chief Elections Officer is authorized to provide specified election services and supplies in conjunction therewith.
