

**AMENDMENT NO. 7 TO AGREEMENT
BETWEEN THE COUNTY OF SAN MATEO AND
GRANICUS INC.**

THIS AMENDMENT TO THE AGREEMENT, entered into this ____ day of _____, 20____, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Granicus Inc., hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an agreement for a Software as a Service (SaaS) solution for E-mail Subscription services on October 17, 2013; and

WHEREAS, on October 2, 2014, the parties executed Amendment No. 1 to extend the term through October 31, 2015, and increase the amount of the Agreement by \$43,260 for an amount not to exceed \$85,260; and

WHEREAS, on October 15, 2015, the parties executed Amendment No. 2 to extend the term through October 31, 2016, and increase the amount of the Agreement by \$45,423 for an amount not to exceed \$130,683; and

WHEREAS, on October 4, 2016, the parties executed Amendment No. 3 to extend the term through October 31, 2017, and increase the amount of the Agreement by \$49,965.30 for an amount not to exceed \$180,648.30; and

WHEREAS, on October 17, 2017, the parties executed Amendment No. 4 to extend the term through October 31, 2018, and increase the amount of the Agreement by \$54,961.83 for an amount not to exceed \$235,610.13; and

WHEREAS, on November 13, 2018, the parties executed Amendment No. 5 to extend the term through October 31, 2019, and increase the amount of the Agreement by \$58,809.16 for an amount not to exceed \$294,419.29; and

WHEREAS, on October 8, 2019, the parties executed Amendment No. 6 to extend the term through October 31, 2022, and increase the amount of the Agreement by \$203,935.47 for an amount not to exceed \$498,354.76; and

WHEREAS, the parties wish to amend the Agreement for continued E-mail Subscription services, extending the term through October 31, 2023, and increasing the amount by \$76,313.27 for a not to exceed amount of \$574,668.03.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 2 of the agreement is amended to read as follows:

Contract Term. The term of this Agreement shall be from November 1, 2013, to October 31, 2023, unless terminated earlier by the County with 90 day written notice.

2. Section 3 of the agreement is amended to read as follows:

Payments. In consideration of the services rendered in accordance with all terms, conditions, and specifications set forth herein and any Exhibit(s) or attachment(s) attached hereto, County shall make payment to Contractor in the manner specified herein and in Exhibit A. In the event that the County makes any advance payments, Contractor agrees to refund any amounts in excess of the amount owed by the County at the time of contract termination. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall total payment for services under this Agreement exceed **Five Hundred Seventy-Four Thousand, Six Hundred Seventy-Four Dollars and Three Cents (\$574,668.03)**.

3. Original Exhibit A, Section 2 is amended to include the following:

**Total amount due for the 11/1/2022-10/31/2023 period is \$76,313.27.
Invoice is to be submitted on an annual basis during this period.**

The County will submit payment within Net thirty (30) days of receipt of invoice.

The invoice will include the following:

- Agreement Number
- Actual services performed, and amount billed
- The net amount for which payment is due

Contractor agrees that the requirements of this Agreement pertaining to the protection of proprietary rights and confidentiality shall survive termination of this Agreement.

4. **All other terms and conditions of the agreement dated November 1, 2013, as**

amended, between the County and Contractor shall remain in full force and effect.
