RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH TRIUNE INFOMATICS, INC. FOR THE SERVICES OF SHALINI GUDA PADMANATH, EXTENDING THE TERM END DATE FROM OCTOBER 31, 2022, TO JUNE 30, 2023, AND INCREASING THE AMOUNT PAYABLE BY \$130,680 TO AN AMOUNT NOT TO EXCEED \$326,194

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on September 8, 2021, the County entered into an Agreement with

Triune Infomatics, Inc. to provide Project Coordination services through July 31, 2022 in the amount of \$170,000; and

WHEREAS, on July 21, 2022, the parties amended the Agreement to extend the

term from September 13, 2021 through July 31, 2022 to September 13, 2021 through

October 31, 2022, and increase the amount payable by \$25,514 for an amount not to

exceed \$195,514; and

WHEREAS, the County and Triune Infomatics, Inc. now wish to further amend

the Agreement to extend the term from September 13, 2021 through October 31, 2022

to September 13, 2021 through June 30, 2023, and increase the amount payable by

\$130,680, to an amount not to exceed \$326,194; and

WHEREAS, this Board has been presented with a form of such Amendment, has examined and approved it as both form and content, and desires to enter into it.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED:

- The President of the Board of Supervisors be and is hereby authorized and directed to execute Amendment to Agreement with Triune Infomatics, Inc., for project coordination services for the Assessor Property Assessment System (APAS) on behalf of the County of San Mateo, and the Clerk of the Board shall attest to the President's signature thereto.
- 2. Authority is given to the Assessor-County Clerk-Recorder & Chief Elections Officer or designee to execute contract amendments to modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services as long as the modified term of services is/are within the current or revised fiscal provision.
