**RESOLUTION AUTHORIZING AN AGREEMENT WITH THE CENTRAL LABOR
COUNCIL PARTNERSHIP TO PROVIDE INDEPENDENT LIVING PROGRAM
SERVICES FOR FORMER AND CURRENT ELIGIBLE SAN MATEO COUNTY
FOSTER YOUTH FOR THE TERM OF NOVEMBER 1, 2022 THROUGH OCTOBER
31, 2025 FOR A TOTAL OBLIGATION AMOUNT NOT TO EXCEED \$577,434**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Independent Living Program (ILP), authorized by the Foster Care Independence Act of 1999 (Public Law 106-169), provides training, services, and benefits to assist current and former foster youth in achieving self-sufficiency prior to, and after leaving, the foster care system; and

WHEREAS, the Human Services Agency (“HSA”) Children and Family Services (“CFS”) branch’s mission is to enhance the well-being of children, adults, and families by providing professional, responsive, caring, and supportive services; and

WHEREAS, On June 15, 2022, HSA issued a Request for Proposals (RFP) to identify a provider of ILP services and Central Labor Council Partnership (CLCP) was selected based on their experience and method for providing services as outlined in the evaluation criteria of the RFP; and

WHEREAS, CLCP is a collaboration of three organizations that includes Regenerate California Innovation, ProPath, Inc., and the Central Labor Council of Fresno, Madera, Tulare, and King Counties (CLC); and

WHEREAS, CLC is the lead agency for the CLCP and will hold this agreement with the County that will provide ILP services to eligible foster youth that will be based on the individual identified needs and goals as documented in the youth's Transitional Independent Living Plan (TILP) which is designed to assist youth with education, career development, financial budgeting skills, health, safety, housing, and permanency; and

WHEREAS, HSA requests to enter into an agreement with CLCP for the term of November 1, 2022 to October 31, 2025 for a total obligation amount not to exceed \$577,434; and

WHEREAS, the Board has been presented with a form of such agreement, has examined and approved it as to both form and content, and desires to enter into same.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board of Supervisors be and is hereby authorized and directed to execute said Agreement for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Director of the Human Services Agency or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
