POSITIONS, ADD THREE POSITIONS, AND SET THE SALARY OF ONE  
CLASSIFICATION; AND ACCEPT THE UPDATED REPORT OF BIWEEKLY  
SALARIES BY CLASSIFICATION**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

**WHEREAS**, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

**WHEREAS**, San Mateo County Ordinance No. 07303 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

**NOW THEREFORE, IT IS HEREBY ORDERED** that the Board of Supervisors authorizes an amendment to Master Salary Resolution 079043 as follows:

**SECTION 2:** Part 14 of the Resolution is amended as indicated:

ORGANIZATION 40000 OFFICE OF SUSTAINABILITY

1. Salary for Item D008, Resource Conservation Program Manager is set at \$58.89 to \$73.59 per hour.

#### ORGANIZATION 61000 BEHAVIORAL HEALTH AND RECOVERY SERVICES

1. Item E415, Patient Services Supervisor-Exempt is decreased by 1 position for a new total of 6 positions.
2. Item D182S, Management Analyst Series is increased by 1 position for a new total of 4 positions.

#### ORGANIZATION 62400 FAMILY HEALTH SERVICES

1. Item E420, Medical Office Specialist is decreased by 1 position for a new total of 13 positions.
2. Item V260S, IS Support Series is increased by 1 position for a new total of 1 position.
3. Item G117, Senior Community Worker is increased by 1 position for a new total of 15 positions.

#### ORGANIZATION 66000 SAN MATEO MEDICAL CENTER

1. Item D154, Clinical Services Manager II-Nursing is decreased by 1 position for a new total of 3 positions.
2. Item D212, Deputy Director of Nursing Services is increased by 1 position for a new total of 2 positions.
3. Item E410, Storekeeping Supervisor-Exempt is decreased by 1 position for a new total of 0 positions.

4. Item F080, Central Services and Supply Supervisor-Exempt is increased by 1 position for a new total of 2 positions.
