**RESOLUTION SUPPORTING AN APPLICATION TO THE SAN MATEO COUNTY
TRANSPORTATION AUTHORITY FOR CYCLE 6 PEDESTRIAN AND BICYCLE
PROGRAM FUNDING FOR THE ALPINE ROAD CORRIDOR IMPROVEMENT
PROJECT**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the County of San Mateo Department of Public Works (Department/Sponsor) has identified roadway improvements to the Alpine Road Corridor to improve safety for drivers, bicyclists, and pedestrians using the corridor; and

WHEREAS, the Sponsor has developed the Alpine Road Corridor Improvement Project (Project) to reduce congestion, increase visibility, provide crosswalk improvements, and dedicated buffered bicycle lanes; and

WHEREAS, it is estimated to cost \$990,000 to implement the Project scope to complete a Project Initiation Document for improvements on Alpine Road near Highway 280; and

WHEREAS, the Department is seeking \$890,000 in grant funding for the Project; and

WHEREAS, the San Mateo County Transportation Authority (TA) issued a Call for Projects for the Cycle 6 Measures A and W Pedestrian and Bicycle Program on August 4, 2022; and

WHEREAS, the TA requires the Department's governing board resolution:

1. Supporting the Project and application for \$890,000 in TA Measures A and W Pedestrian and Bicycle Program funds for Project; and
2. Committing the Sponsor to the completion of the Project, including the commitment of matching funds in the amount of \$100,000 needed for implementation; and
3. Certifying that any funds awarded by the San Mateo County Transportation Authority will be used to supplement existing funds for program activities and will not replace existing funds or resources; and
4. If funds awarded, authorizing the Public Works Director, or designee, to sign a funding agreement or memorandum of understanding (MOU) with the TA for TA Measures A and W pedestrian and bicycle program funding for the Project and to take any other actions necessary to give effect to this resolution.

NOW, THEREFORE, IT IS RESOLVED that the Board of Supervisors:

1. Directs the Department to submit an application to the San Mateo County Transportation Authority for Measure A and W Pedestrian and Bicycle Program funds for \$890,000 for the Alpine Road Corridor Improvement Project.
2. Authorizes the Public Works Director, or designee, to execute a funding agreement or MOU with the San Mateo County Transportation Authority to encumber TA Measures A and W Pedestrian and Bicycle Program funds.
3. Commits to the completing of the Project, including contributing \$100,000 of matching funds needed for implementation, if the requested TA funds are awarded.
4. Certifies that any funds awarded by the San Mateo County Transportation Authority will be used to supplement existing funds for program activities and will not replace existing funds or resources.
5. Authorizes the Public Works Director, or designee, to take any other actions necessary to give effect to this resolution.
