RESOLUTION AUTHORIZING A) AN AGREEMENT WITH PACIFIC COAST DREAM MACHINES TO CONDUCT THE ANNUAL PACIFIC COAST DREAM MACHINES FUNDRAISING EVENT AT THE HALF MOON BAY AIRPORT ON THE LAST SUNDAY OF APRIL 2023, 2024, AND 2025; AND B) A WAIVER OF THE 12,500-POUND WEIGHT RESTRICTION AT THE HALF MOON BAY AIRPORT ON THE DAY OF THE EVENT

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, California Government Code Section 25536 allows a county, by four-fifths (4/5ths) vote of its board of supervisors, to enter into agreements to permit activities on land held by the county for airport purposes; and

WHEREAS, Pacific Coast Dream Machines has requested the use of the Half Moon Bay Airport (Airport) for its annual Pacific Coast Dream Machines (Event); and

WHEREAS, a waiver of the 12,500-pound weight restriction at the Airport for aircraft participating in the Event has been recommended; and

WHEREAS, there has been presented to this Board for its consideration and acceptance, an Agreement between the County of San Mateo and Pacific Coast Dream Machines which allows the Event to be conducted at the Airport on the last

Sunday in April of 2023, 2024, and 2025; and

WHEREAS, the agreement provides that Pacific Coast Dream Machines will pay the Airport \$1,000 per day for each annual event, for a total of five (5) days, for use of the facility and will reimburse the Airport for the cost of staff time related to Event setup, execution, and breakdown and repair of any damage incurred; and

WHEREAS, this Board has been presented with a form of said Agreement and has examined and approved same as to both form and content, and desires to enter into the same.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that:

- The President of this Board be, and is hereby, authorized and directed to execute said agreement for and on behalf of the County of San Mateo with Pacific Coast Dream Machines which allows them to conduct the Pacific Coast Dream Machines Event at the Half Moon Bay Airport on the last Sunday in April of 2023, 2024, and 2025 and the signature of the Clerk of this Board shall attest thereto.
- The Board authorizes a waiver of the 12,500-pound weight restriction at the
 Half Moon Bay Airport for aircraft participating in the Event as set forth in the
 agreement whose execution is authorized by this resolution.
