## RESOLUTION AUTHORIZING AN AGREEMENT WITH ZOMO HEALTH LLC TO PROVIDE WELLNESS PROGRAM SERVICES FOR THE COUNTY FOR THE TERM OF JANUARY 1, 2023 THROUGH DECEMBER 31, 2025, IN AN AMOUNT NOT TO EXCEED \$ 2,090,850

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, since 2018, the County of San Mateo Wellness Program has used the PreventionCloud virtual wellness engagement portal hosted by health management company Zomo Health LLC to offer a Wellness Dividend Program, Online Health Assessment, wellness event registration, wellness screenings, emotional wellbeing resources, activity challenges, and wellness videos to support County employees and their spouses; and

WHEREAS, the Wellness Program also utilizes Zomo Health to provide administration and reporting of the Dividend Program and Online Health Assessment, management of vendor contracts, marketing materials, and other wellness activities and services including a Health Coach, Wellness Nurse, Registered Dietician, and health education classes; and

WHEREAS, the County undertook a Request for Proposal (RFP) process in 2022, assisted by Alliant, the County's benefits broker, to evaluate the worksite wellness vendor market for the County's Wellness Program services; and

WHEREAS, the Selection Committee recommends that the County continue services for the County's Wellness Program with Zomo Health because it is the only RFP applicant that is capable of hosting a custom annual Health Assessment and serving the breadth of the County's current Whole Person Well-being program, including its ability to customize the platform and user experience to meet our program; retain County's proprietary Health Risk Assessment; offer a large number of services included in the cost per employee; offer a large number of vendors, including fitness instructors, health coaches, registered dieticians, massage therapists, registered nurses, and health educators; and provide enhanced reporting and analytics that are reliable, valid, and HIPAA compliant to allow the County to make informed decisions regarding upcoming wellness strategies; and

WHEREAS, the Director of Human Resources recommends that the County execute a 3-year agreement with Zomo Health LLC for Wellness Program services from January 1, 2023 to December 31, 2025; and

WHEREAS, there has been presented to this Board of Supervisors for its consideration the agreement and the Board has approved it as to both form and content and desires to enter such agreement; and

### NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

President of this Board of Supervisors be and is hereby authorized and directed to execute said agreement for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

**BE IT FURTHER RESOLVED** that the Board of Supervisors authorizes the Human Resources Director or the Director's designee to execute contract amendments with Zomo Health LLC and may further modify to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
