AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND MISSION ASSET FUND

THIS AMENDMENT TO THE GRANT AGREEMENT, entered into this twelfth day of December, 2022, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Mission Asset Fund, hereinafter called "MAF";

WITNESSETH:

WHEREAS, the County and MAF entered into a grant agreement (the "Agreement") on November 9, 2021, for the provision of financial assistance to families that are ineligible for the federal child tax credit; and

WHEREAS, the County and MAF wish to amend the Agreement to remove a condition for releasing the second payment of the grant.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

- **1.** Section 1.a. under 1. Grant Purpose & Disbursement of the agreement is amended to read as follows:
 - a. ONE MILLION TWO HUNDRED TWENTY FIVE THOUSAND ONE HUNDRED FIFTY DOLLARS (\$1,225,150) will be paid by the County to MAF upon due execution of this Agreement by each Party. The remaining TWO MILLION DOLLARS (\$2,000,000) will be paid by the County to MAF upon receipt by the County of progress reports from MAF documenting enrollment in the Grant program of at least 500 San Mateo County families. MAF will apply the Grant funding provided through this Agreement to provide financial support to a cohort of at least 500 San Mateo County families, as more specifically described below. Of the total grant funds, the following amounts may be used to fund technology and personnel associated with training/family support and evaluation, with the remainder used for cash distribution to San Mateo County families:

January 1- December 31, 2023	\$110,000
January 1- December 31, 2024	\$105,000

2. All other terms and conditions of the Agreement dated November 9, 2021, between

the County and MAF shall remain in full force and effect.
