RESOLUTION AUTHORIZING AMENDMENT NO. 1 TO THE AGREEMENT WITH ABLE PLUMBING, SEWER & DRAIN FOR SEWER SERVICES AT VARIOUS COUNTY FACILITIES, INCREASING THE AMOUNT BY \$380,000, FOR A NEW NOT-TO-EXCEED AMOUNT OF \$579,000, AND EXTENDING THE TERM TO MAY 24, 2026

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Department of Public Works (Department) is responsible for managing the cleaning and repair services for the sewer lines throughout the County's facility portfolio; and

WHEREAS, the Department requested bids for sewer services in March 2021, using the informal bid process and seeking three quotes; and

WHEREAS, two sewer service companies submitted their proposals and Able Plumbing, Sewer & Drain (Able) was selected through the process by offering the best rates and the ability to service the County's facility portfolio; and

WHEREAS, on May 25, 2021, the Department executed an Agreement with Able, in the amount of \$199,000, to provide emergency sewer services including pumping out sewer pits and grease traps at various County facilities; and

WHEREAS, the County recently experienced multiple sewer back-ups that required Able's emergency services; and

WHEREAS, The Department anticipates there will be more sewer back-up emergencies and repairs needed and to be able to respond appropriately, the Department recommends that the Agreement be increased in duration and amount; and

WHEREAS, the Department of Public Works is recommending Amendment No. 1 to the Agreement with Able to increase the amount by \$380,000, for a new not-to-exceed amount of \$579,000, and extend the term for two years to May, 24, 2026; and

WHERAS, this Board has considered and concurs with the recommendation of the Director of Public Works; and

WHERAS, this Board has been presented with a form of said Amendment and has examined and approved same as to both form and content, and desires to enter into same.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of the Board of Supervisors is hereby authorized and directed to execute said Agreement for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto.

**BE IT FURTHER RESOLVED,** the Director of Public Works is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
