**RESOLUTION AUTHORIZING AN AMENDMENT TO MASTER SALARY
RESOLUTION 079043 TO DELETE SIX POSITIONS, ADD SEVEN POSITIONS, SET
THE SALARY RANGE FOR EIGHT CLASSIFICATIONS, AND CONVERT ONE
UNCLASSIFIED POSITION TO CLASSIFIED; AND ACCEPT THE UPDATED
REPORT OF BIWEEKLY SALARIES BY CLASSIFICATION**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

WHEREAS, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

WHEREAS, San Mateo County Ordinance No. 073703 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

NOW THEREFORE, IT IS HEREBY ORDERED that the Board of Supervisors authorizes an amendment to Master Salary Resolution 079043 as follows:

SECTION 1: Part 14 of the Resolution is amended as indicated:

ORGANIZATION 12000 COUNTY EXECUTIVE'S/CLERK OF THE BOARD

1. Item D185, Senior Management Analyst is decreased by 2 positions for a new total of 1 position.
2. Item D180, Principal Management Analyst is increased by 1 position for a new total of 4 positions.
3. Salary Range for Item D238, Assistant County Chief Financial Officer is set at \$91.35 to \$114.17 per hour.

ORGANIZATION 18000 INFORMATION SERVICES DEPARTMENT

1. Item E337, Office Specialist is increased by 1 position for a new total of 1 position.

ORGANIZATION 38000 PLANNING AND BUILDING DEPARTMENT

1. Item R065S, Planner Series is increased by 1 position for a new total of 15 positions.
2. Salary for Item J068, Building Plans Examiner I is set at \$41.36 to \$51.70 per hour.
3. Salary for Item J069, Building Plans Examiner II is set at \$50.70 to \$63.38 per hour.

4. Salary for Item G192, Peer Support Specialist II is set at \$30.61 to \$38.24 per hour.

2. Item G072, Overpayments and Collections Supervisor is increased by 1 position for a new total of 2 position.

3. Item D091, Human Services Manager II is decreased by 1 position for a new total of 10 positions.
4. Item D236, Children's Services Program Manager II is increased by 1 position for a new total of 4 positions.
5. Item G075, Overpayments and Collections Analyst I is set at \$31.14 to \$38.93 per hour.
6. Item G074, Overpayments and Collections Analyst II is set at \$35.27 to \$44.08 per hour.
