## SECOND AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND PENINSULA CONFLICT RESOLUTION CENTER

## WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement on December 7, 2021, for alcohol and other drug prevention services, community capacity building, parent project classes and mental health first aid, for the term of July 1, 2021 through June 30, 2022, for a maximum obligation of \$238,563; and

WHEREAS, on July 18, 2022, the Chief of San Mateo County Health approved a first amendment to increase the maximum amount by \$259,754 for a total amount not to exceed \$498,317 and extend the term through June 30, 2023; and

WHEREAS, the parties wish to amend the Agreement to increase the maximum amount by \$186,869 for a total amount not to exceed \$685,186 and extend the term of the Agreement by nine months through March 31, 2024.

## NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 4. Payments of the agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions and specifications set forth herein and in Exhibit A2, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B2. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall the County's total fiscal obligation under this Agreement exceed SIX HUNDRED EIGHTY-FIVE THOUSAND ONE HUNDRED EIGHTY-SIX DOLLARS (\$685,186).

2. Section 5. Term and Termination of the agreement is amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from July 1, 2021 through March 31, 2024.

3. All other terms and conditions of the agreement, as previously amended, between the County and Contractor shall remain in full force and effect.
