## AMENDMENT NO. 3 TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND CSG CONSULTANTS

THIS AMENDMENT NO. 3 TO THE AGREEMENT, entered into this day of
, 20, by and between the COUNTY OF SAN MATEO, hereinafter called
"County," and CSG Consultants, hereinafter called "Contractor";

## WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for the purpose of providing independent plan check and building inspection services on an as needed basis for the planning and building department on July one, 2022 for an amount not to exceed \$1,000,000 and a term of July 1, 2022 through June 30, 2025; and

WHEREAS, the parties entered into Amendment No. 1 to this Agreement to include additional contract staffing services, including permit technicians and clerical/administration staff on an as-needed basis on September 26, 2022, with no change to the agreement amount or term; and

WHEREAS, the parties entered into Amendment No. 2 to this Agreement to increase the County's fiscal obligation under this agreement by \$25,000 for a total not to exceed amount of \$1,025,000 with no change to the term; and

WHEREAS, the parties wish to amend the Agreement to increase counties fiscal obligation under this Agreement by \$100,000 for a total not to exceed amount of \$1,125,000 with no change to the term.

## NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

**1.** The third sentence of Section 3, "Payments," of the Agreement is amended to read as follows:

In no event shall County's total fiscal obligation under this agreement exceed One

- Million, One Hundred Twenty-five Thousand dollars (\$1,125,000).
- 2. Revised Exhibit B (rev. August 29, 2022) is revised to reflect the new not to exceed amount, such that the last sentence of the second paragraph is revised to read as follows:
  - In no event shall payment for services exceed one-million, one hundred twenty-five thousand dollars (\$1,125,000).
- 4. All other terms and conditions of the agreement dated July 1, 2022, between the County and Contractor shall remain in full force and effect.
