

### Sewer/Sanitation District Rates & Charges Background Information

- The County operates 10 sewer/sanitation districts.
- Each district is an independent entity with its own separate budget.
- The Sewer Rates are used to calculate Sewer Service Charges (the Fee for Providing Sewer Service) for each parcel in the districts.
- The Sewer Service Charges are levied on the Tax Bill.



### Sewer/Sanitation District Rates & Charges Adopted and Proposed Rates

- In 2020, Sewer Rates were set for 3 years for the 8 districts
- Proposing to set rates for 5 years for the 8 districts to adequately fund the following:
  - anticipated cost increases for operation and maintenance and sewage treatment
  - anticipated cost for capital improvements within the 8 districts
  - anticipated cost of work at the wastewater treatment plant and on the downstream collection systems



#### Sewer/Sanitation District Rates & Charges

#### Sewer Service Rates and Charges pay for:

- Operation and maintenance of sewer collection system
- Repairs to and replacement of the aging pipes
- Inspection and assessment of pipe conditions
- Emergency response (24/7) to clear blockages and cleanup overflows
- Operation and maintenance costs at the wastewater treatment plant
- Improvements to the wastewater treatment plants
- Compliance with local, state, and federal health, safety, and environmental protection regulations



#### Sewer/Sanitation District Rates & Charges

- There are major Capital Improvement Projects (CIPs) at the Silicon Valley Clean Water (SVCW) wastewater treatment plant that the 8 Districts flow into:
  - In 2008 SVCW began work on CIPs to replace equipment which have reached the end of their useful lives. This work is estimated to cost \$950 million in total.
  - SVCW estimates \$330 million in CIP expenditures over the next decade
  - SVCW will be charging the member agencies (Redwood City, San Carlos, Belmont, and West Bay Sanitary District) for the CIPs
  - The 8 Districts' sewage flow through Redwood City and San Carlos and will have to pay for their shares to these two member agencies

# Sewer/Sanitation District Rates Completed Capital Improvement Projects

- ➤ The following projects in the Fair Oaks Sewer Maintenance District replaced over 2.3 miles of pipes from 2020-2023 for a total construction cost of \$6.8 M:
  - Middlefield Rd Sewer Rehabilitation Project replaced over 6,700 feet of pipe
  - 2<sup>nd</sup> Ave, 3<sup>rd</sup> Ave, and Alexander Ave Sewer Rehabilitation
     Project replaced over 2,200 feet of pipe
  - Encina Ave and Oak Dr Sewer Rehabilitation Project replaced over 2,200 feet of pipe
  - Loyola Ave Sewer Rehabilitation Project replaced over 1,000 feet of pipe

# Sewer/Sanitation District Rates Completed Capital Improvement Projects

- ➤ The 2019 Multi-District Sewer Rehabilitation Project, completed in 2020, replaced or rehabilitated over 5,500 feet of pipes in the following districts:
  - Burlingame Hills Sewer Maintenance District (160 feet)
  - Devonshire County Sanitation District (1,460 feet)
  - Emerald Lake Heights Sewer Maintenance District (1,900 feet)
  - Harbor Industrial Sewer Maintenance District (1,000 feet)
  - Kensington Square Sewer Maintenance District (1,000 feet)
  - Oak Knoll Sewer Maintenance District (40 feet)
  - Scenic Heights County Sanitation District (240 feet)



- Virtual community meetings were held on the following dates:
  - May 9, 2023 Edgewood, Kensington Square, and Oak Knoll Sewer Maintenance Districts
  - May 11, 2023 Devonshire and Scenic Heights County Sanitation Districts, and Harbor Industrial Sewer Maintenance District
  - May 15, 2023 Emerald Lake Heights Sewer Maintenance District
  - May 16, 2023 Fair Oaks Sewer Maintenance District

### Sewer/Sanitation District Proposed Rates FY 2023-24 through FY 2027-28

- Sewer/Sanitation District <u>Rates</u> are set by Ordinance and follow this process:
  - May 23, 2023 Introduce Amending Ordinance Code to set FY 2023-24 through 2027-28 Sewer Service Rates for 8 Districts; and
  - July 25, 2023 Second Reading of Ordinance and Adoption of Sewer Service Rates



# Sewer/Sanitation District Sewer Charges Based on Rates for FY 2023-24

- Health and Safety Codes & SMC Ordinance Code stipulate the process for increasing Sewer Service Charges (fee for service) based on the sewer rates set. The process includes:
  - May 23, 2023 Schedule a public hearing
  - July 25, 2023 Hold a public hearing on the Sewer
     Service Charges calculated based on the Sewer Rates
    - Consider objections and protests at the public hearing
    - Approve imposition of Sewer Service Charges based on Sewer Rates on properties within the districts on the property tax roll for FY 2023-24
