## SECOND AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND PUENTE DE LA COSTA SUR

## WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement on November 16, 2021, for Project SUCCESS services and Trauma-Informed Co-occurring Prevention Services, for the term of July 1, 2021 through June 30, 2022, for a maximum obligation of \$335,771; and

WHEREAS, on July 6, 2022, the Chief of San Mateo County Health approved a first amendment to increase the maximum amount by \$366,293 for a total amount not to exceed \$702,064 and extend the term through June 30, 2023; and

WHEREAS, the parties wish to amend the Agreement to increase the maximum amount by \$263,274 for a total amount not to exceed \$965,338 and extend the term of the Agreement by nine months through March 31, 2024.

## NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 3. Payments of the agreement is amended to read as follows:

In consideration of the services provided by Contractor in accordance with all terms, conditions and specifications set forth herein and in Exhibit A2, County shall make payment to Contractor based on the rates and in the manner specified in Exhibit B2. County reserves the right to withhold payment if County determines that the quantity or quality of the work performed is unacceptable. In no event shall the County's total fiscal obligation under this Agreement exceed NINE HUNDRED SIXTY-FIVE THOUSAND THREE HUNDRED THIRTY-EIGHT DOLLARS (\$965,338).

2. Section 4. Term of the agreement is amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from July 1, 2021 through March 31, 2024.

- 3. Sections A F remain the same.
- 4. All other terms and conditions of the agreement, as previously amended, between the County and Contractor shall remain in full force and effect.
