RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH THE SAN MATEO HEALTH COMMISSION DBA HEALTH PLAN OF SAN MATEO FOR SERVICES TO MEDI-CAL MEMBERS, FOR THE TERM OF JANUARY 1, 2015, THROUGH DECEMBER 31, 2024, FUNDED THROUGH INTERGOVERNMENTAL TRANSFERS

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, since 1994 this Board of Supervisors has approved agreements with San Mateo Health Commission dba Health Plan of San Mateo (HPSM), for the provision of healthcare and other services to HPSM participants; and

WHEREAS, this Board has approved agreements for Inter-Governmental

Transfers (IGTs) to help pay for services provided by County Health; and

WHEREAS, this Board supports the continued participation of County Health in providing healthcare and other services to HPSM Medi-Cal participants; and

WHEREAS, this Board entered into an agreement with the HPSM on April 11, 2017, for the term of July 1, 2015 through September 30, 2019 to provide supplemental payments to County Health for services provided to HPSM members, based on an IGT arrangement; and

WHEREAS, on June 6, 2017 this Board amended that agreement to include additional payments from the HPSM for FY 2015-16 and FY 2016-17 for the term of July 1, 2015 through September 30, 2019 and such payments are provided for in Amendment No. 1 and Amendment No. 2 to that agreement; and

WHEREAS, on February 27, 2018 this Board amended that agreement to include additional payments from the HPSM for FY 2016-17 for the term of January 1, 2017 through September 30, 2019 and such payment is provided for in Amendment No. 3 to that agreement; and

WHEREAS, on September 4, 2018, this Board amended that agreement to include additional payments from the HPSM for calendar year 2016 for the term of January 1, 2015 to December 31, 2018 and such payment is provided for in Amendment No. 4 to that agreement; and

WHEREAS, on April 9, 2019, this Board amended that agreement to include additional payments from the HPSM for FY 2017-18 for the term of January 1, 2015 to December 31, 2020 and such payment is provided for in Amendment No. 5 to that agreement; and

WHEREAS, on January 7, 2020, this Board amended that agreement to include additional payments from the HPSM for calendar year 2017 for the term of January 1, 2017 to December 31, 2020 and such payment is provided for in Amendment No. 6 to that agreement; and

WHEREAS, the Chief or San Mateo County Health further amended that agreement, pursuant to this Board's resolution allowing such amendments, to extend

the termination date for Amendments No. 1 and No.3 from June 30, 2019, to December 31, 2020, to accommodate additional payments from the HPSM payments, as provided for in Amendments No. 1 and No.3 to the agreement and produced Amendment No. 7; and

WHEREAS, on June 30, 2020, this Board further amended that agreement to include additional payments from the HPSM for FY 2018-19 for the term of January 1, 2017 to December 31, 2022 and such payment is provided for in Amendment No. 8 to that agreement; and

WHEREAS, on March 9, 2021, this Board further amended said agreement to include additional payments from the HPSM for FY 2019-20 for the term of January 1, 2015 through December 31, 2024 and such payment is provided for in Amendment No. 9; and

WHEREAS, the County Health now wishes to further amend that agreement to include additional payments from the HPSM for calendar year 2021 for the term of January 1, 2015 through December 31, 2024 and such payment is provided for in Amendment No. 10, which staff has been presented to this Board for its consideration; and

WHEREAS, the Board has reviewed Amendment No. 10, has approved it both as to form and content, and desires to enter into it.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

President of the Board of Supervisors is hereby authorized and directed to execute said

Amendment No. 10 for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED, that the Chief of San Mateo County Health or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
